pay fo much as the faid fales shall amount to, after deducting the aforesaid expences attending the same; faving the right of any creditor of the faid Archibald Buchanan, by judgment obtained before the judgment rendered as aforefaid on behalf of this state against the faid Nicholas Rogers and wife, the heir of the faid Archibald; and faving also to the laid Nicholas Rogers and wife the costs by them fullained in the fuits against them by this state, if by law they are entitled to retain the said costs out of the value of the lands descended to the wife of the faid Nicholas.

VI. AND BE IT ENACTED, That the faid trustees shall be allowed a commission of five per cent. for Commission allowed. their trouble in executing the powers intrusted to them by virtue of this act.

C H A P.

An ACT for the payment of the journal of accounts. Lib. TBH.

No. B. fol, 273.

WHEREAS it appears by the journal of accounts and lift of debts of this session, wherein is Preamble. included the journal and lift of debts of last festion, that there is now due from this state the fum of eleven thousand five hundred and ninety-fix pounds two shillings and one penny three farthings current money;

II. BE IT ENACTED, by the General Affembly of Maryland, That the treasurer of the western shore Treasurer to shall, and he is hereby authorised and required, to pay the several persons, their executors, administ pay, &c. trators, assigns or orders, or to such of them as shall offer to receive the same, the several sums of current money allowed to them respectively, as they appear to be settled and ascertained by the journal of accounts aforefaid of this prefent fession.

III, AND BE IT ENACTED, That all or any of the public creditors on the journal may have their Creditors may election to receive a certificate or certificates from the treasurer of the western shore, signed by him, receive certificates and expressing, in the whole of such certificates, the sum of current money due to such creditor or creditors respectively, which certificates shall be payable to the collectors of taxes due on any public affessment, or in the treasury for interest due, or composition on certificates; and any collector may pay any fuch certificates into the treasury as specie, without any oath concerning his receipt thereof; or if any of the faid certificates shall not be so discounted, the treasurer of the western or eastern shore shall receive the said certificates and pay the money due thereon to the hearer out of any money in the treasury, not appropriated to congress; and the treasurer of the western shore shall, on the request of any person having an allowance on the said journal, and not taking a certificate as aforefaid, retain in his hands, of the money which shall first come into the treasury, not appropriated to congress, sufficient wherewith to satisfy such allowance, or the balance thereof, for which a certificate shall not have been given, and shall-pay the same to the person to whom the same is due, or his
