VII. AND BE IT ENACTED, That, the faid truffecs, or the major part of them, appointed as To purchase aforefaid, fliall and they are hereby authorifed, directed and required, to buy and purchase, in feesimple, a quantity of land in the laid county, not exceeding fifty acres, or, less than fix, and the faid truffees, or the major part of them, appointed as aforefaid, are hereby authorifed, directed and required, to agree and contract, with a workman or workmen to undertake, erect, build, and in a workman-like manner complete and finish, on the laid land when so purchased, good, strong, sufficient cient and convenient houses, habitations and dwellings, for the reception of the poor of faid county; and of fuch vagrants, beggars, vagabonds and other offenders, as shall be committed by virtuo of this act, and they shall appropriate one part thereof to be called the alms-house, to and for the reception and lodging of the poor of the faid county, and another part or parts thereof to be called the work-house, to and for the reception and lodging of all fuch vagrants, beggars, vagabonds and other offenders, as shall be committed in virtue of this act; and the aforesaid land when bought, and the aforefaid houses, habitations and dwellings, when built, shall be, and they are hereby enacted and declared to be, vefted in the faid truftees, and their fuccesfors, for ever, as their estate and inheritance; for the uses and purposes by this act directed and expressed.

VIII. AND BE IT ENACTED, That the faid trustees, or the major part of them, shall, and they And buy beds, are hereby authorifed, directed and required, after the houses, habitations and dwellings aforelaid, &c. shall be completely erected and finished, to buy and purchase, for the use and employment of the poor of the faid county, and the vagrants, beggars, vagabonds and other offenders, who shall be committed by virtue of this act, sufficient beds, bedding, working tools, kitchen utenfils, cows, horses, and other necessaries; and the faid trustees are hereby directed and required to purchase the faid quantity of land not exceeding fifty acres, or less than fix, in such part of faid county as they, or a majority of them, may think most convenient; and the said trustees are hereby directed and required to keep a fair, distinct and clear account, in writing, of all the monies by them received and expended in virtue of this act, and to return a true copy thereof, and fliew and produce the voucliers to support the same, to the justices of the said county, at their June court yearly, to be by the faid justices inspected and examined, which said accounts shall be lodged with the clerk of the faid court.

IX. AND BE IT ENACTED, That after the expiration of the faid three years, the justices of Ca- Justices to levy roline county court aforesaid for the time being shall and they are hereby empowered to assess and money, &c. levy on all the property in faid county subject and liable to affestment, at the time of laying their county rate, a fum of current money not exceeding five shillings on every hundred pounds of property as aforesaid in the said county, together with the collector's commission of fix per cent., for collecting the same; which said assessment shall be made, levied, collected and paid, in the same manner as herein before is directed; which faid money, when so as aforesaid collected, shall be paid by the collector to the order of fuch trustees, or the major part of them, under their common seal, who are hereby authorised and required to receive and apply the same to and for the use, benefit and charge, of maintaining the poor, vagrants, beggars, vagabonds and other offenders, in the purchaling provisions and other necessaries for the use and labour, in paying a doctor for his salary and medicines, in providing men and women ferwants to be under the direction and management of the overfeer of fuch alms and work-house hereafter directed to be appointed, for purchasing materials for the use and employment of all the poor, and all the beggars, vagrants, vagabonds and other offenders, who shall be able to work, and who shall be committed by virtue of this act.

X. And BE IT ENACTED, That the faid trustees, or the major part of them, shall and they are Trustees to hereby authorifed, directed and enjoined, to meet together between the first and tenth of No- meet yearly, vember yearly, and all fuch other times as they shall judge necessary, at the alms and work-house in the faid county, during the continuance of this act, to appoint a fit person to be overseer of the alms and work-house in the said county, and such other proper officers and servants as to them shall appear necessary for carrying on the business of the said corporation, and they, or the major part of them, shall and may agree, and they are hereby empowered to pay the faid overfeer, out of the money raifed and collected as aforefaid, a fum not exceeding feventy-five pounds current money per annum, as a falary, and so pro rate during his continuance in office, and shall then take bond, which the faid overfeer, and any other overfeer to be appointed, shall and is hereby obliged to enter into, with good and fufficient fureties, in the penalty of two hundred pounds current money, payable to the said trustees for the poor, conditioned as follows, to wit: " The condition of
