Who may appoint a treatuter, &c. III. AND BE IT ENACTED, That the faid commissioners may appoint one of their number as treafurer, who is hereby enjoined and empowered to collect and receive all monies subscribed, or that

IV. AND BE IT ENACTED. That the commissioners aforesaid shall ascertain and value what damages may be fultained by any person or persons through whose land the said road may pass, by opening and clearing the same, and the said valuation shall be made before the said commissioners shall proceed to open and clear the same; and in case any proprietor or proprietors, or their guardian or trustee, shall conceive themselves aggrieved by the valuation of the said commissioners, it shall and may be lawful for any justice of the peace for Frederick or Baltimore counties, as the case may be, on application by any person interested, to issue his warrant under hand and seal, directed to any constable of the county, as the case may be, commanding him to summon five freeholders, disinterested as to the faid road, to appear on a day by him to be appointed on the land of the perion making application as aforesaid, and the said freeholders shall respectively repair to some magistrate of one of the faid counties, as the case may be, and take the following oath or affirmation, to wit: "1, A; B. " do swear, or solemnly, sincerely and truly declare and affirm, that I will honestly and faithfully " estimate and value the damage and injury fustained by C. D. by opening a road through the land of " the faid C. D. in pursuance of the directions of this act;" and shall return the damages by them affessed to the faid justice of the peace, and the damages so affessed and returned shall be conclusive; and the party or parties in whose favour the valuation ascertained by the said commissioners, or the damages affested by the faid freeholders, shall be made, shall be entitled to receive the same from the faid commissioners, and the said commissioners shall pay, or secure to be paid, the amount of the said valuation or damages to the respective parties entitled to receive the same, out of the monies to be raifed and collected from the subscriptions to the said road, within the space of six months after the afcertainment of fuch valuation or damages, and before they shall proceed to affect the lands and tenements of the person or persons concerned; provided, that the said road shall not go through any houses, gardens, meadows or orchards, unless with the consent of the owner thereof.
