shares thereafter; and every such stockholder may fell and transfer his stock in the faid bank, or any part thereof, at his pleasure, not being less than one complete share or shares, the transfer being made in the bank books in the presence and with the approbation of the proprietor, or his lawful attorney; the purchaser then to be entitled to all the rights which the original proprietor enjoyed.

V. AND BE IT ENACTED, That as foon as two hundred fhares firall be fubfcribed, the perfons A meeting may hereby empowered to take in subscriptions, or any five of them, may call a meeting of the subscribers, at Baltimore town, after not less than four successive weeks notice in the Baltimore and Annapolis news-papers; and the fubscribers assembled in consequence of such notice shall choose by ballot, from among the subscribers, by a majority of the votes of such as shall be present, or by proxy, twelve directors for the term of one year thereafter, and on the same day annually, for ever thereafter, a like election shall be made; and in case of refusal, death, resignation, disqualification, or removal out; of the state, of any director, the remaining members, at their next meeting thereafter, shall elect; by ballot, another person, qualified as aforesaid, in his place for the residue of the year; the directors, or any nine of them, shall, at their first meeting after every general election, elect, by a majority of the members present, by ballot, from among the stockholders, a president, who shall, whether a director or not, be thereupon entitled to all the powers and privileges of one, and if he was before a director, another director shall be elected as aforesaid, so as to keep up the number of directors prescribed by this act, exclusive of the president; and in case of refusal, death, resignation, disqualification, or removal out of the state, of the president, the directors shall meet, as soon as conveniently can be thereafter, and elect another perion for president, in the manner before directed.

VI. AND BE IT ENACTED, That the prefident and directors, elected as prescribed by this act, President, &c. and their fuccessors in office, shall be and they are hereby incorporated and constituted a body corporate and politic, by the name of The President and Directors of the Bank of Maryland, and by the same name shall have perpetual succession; and the said president and directors, and successors, by the name aforefaid, may fue and be fued, answer and be answered, in any court of law or equity in this state, or elsewhere, and may do and execute any other matter or thing, by the name aforefaid, that they are authorised to do in virtue of this act.

VII. AND BE IT ENACTED, That there be a meeting of the directors quarterly, for the purpose Meetings to be of regulating the affairs of the bank, any feven of whom to make a board, and the board have &c. power to adjourn from time to time; and the prefident, or any three of the directors, may call a special meeting at any other time they may think necessary.

VIII. AND BE IT ENACTED, That the board of directors determine the manner of doing business, Directors to deand the rules and forms to be pursued, appoint and pay the various officers which they may find rules, &c. necessary, and dispose of the money and credit of the bank for the interest and benefit of the proprietors, and make, at the expiration of the first year, a dividend of profit, and ever after half yearly dividends.

IX. AND BE IT ENACTED, That in the appointment of a cashier of the said bank, a majority of Majority necesthe votes of nine directors shall be necessary to a choice.

X. And BE IT ENACTED, That the board shall, at every quarterly meeting, choose three direc- Board to choose tors to inspect the business of the bank for the ensuing three months, and the inspectors so chosen three directors, shall, on the evening of every Saturday, examine into the state of the cash account, and of the notes &c. received and issued, and see that those accounts are regularly balanced and transferred.

XI. AND BE IT ENACTED, That any director, officer, or other person holding any share or capital Persons guilty of the faid bank flock, who shall commit any fraud or embezzlement, touching the money or proper- of fraud may ty of the bank, shall be liable to be prosecuted in the name of the state, by indictment, for the same, &c. in any court of law of this state, and upon conviction thereof shall, besides the remedy that may be had by action in the name of the president and directors of the bank of Maryland for the fraud aforefaid, forfeit all his share or stock in the said bank to the company.

XII. AND BE IT ENACTED, That no stockholder, subscriber or member, of the said corporation, No member an shall be answerable for any losses, deficiencies or failure, of the capital stock of the said corporation, swerable for for any more or larger fum or fums of money what soever but to the amount of the stock, stocks or shares, which shall appear by the books of the said company to belong to him at the time or times when fucli-loss or loss shall be sustained.
