C H A P. the faid commissioners shall assemble together, as soon thereafter as conveniently may be, and nominate and appoint another qualified person to be the clerk of the faid market for the remainder of the year.

Who shall take an oath, &c.

XVII. AND BE IT ENACTED, That every person to be appointed clerk of the said market as aforesaid, before he shall proceed to act as such, shall take an oath, or affirmation, before the said commissioners, that he will diligently and faithfully, according to the best of his skill and judgment, execute and perform the several duties of clerk of the said market, without savour, affection or partiality; and that he will not, directly or indirectly, demand or receive any see or reward for performing such duties, but what is or shall be allowed by law; and the said oath or affirmation shall be administered by the said commissioners, and the taking thereof be entered among their proceedings.

His powers.

XVIII. And BE IT ENACTED, That the clerk of the said market shall have sufficient power and authority, at all times thereaster, to take care and charge of the said market-house, and of the market thereof, and to examine and inspect the victuals and provisions brought thereto for sale; to examine and try the weight of any butter brought to the said market, previously made up in prints or parcels, and if the same shall not be sound of the weight pretended by the person offering the same for sale, to seize and appropriate the same, and if any shall be sound unsound or unwholesome, to seize and destroy the same; and also to try and adjust the scales, weights and measures, used at the said market, by the standards of the county; and if any weights or measures shall be salse or untrue, to seize the same, and on a just alteration thereof, to dispose of the same at public sale to the highest bidder, and to account for the money arising from those sales with the said commissioners.

Market-house, &c. vested, &c.

XIX. AND BE IT ENACTED, That the faid market-house, and the stalls, shambles, issues and appertenances thereof, shall be and the same are hereby vested in the said commissioners, and their fuccessors, for the use and in trust for the benefit and advantage of the inhabitants of the said town; and the clerk of the faid market shall have full power, under the direction of the said commissioners, to rent and hire out the stalls and shambles of the said market-house upon the best terms, and to keep a fair and just account, as well of the persons renting, as of the profits arising from such rents, and to render duplicates of fuch accounts to the faid commissioners annually on the first Monday of April, or oftener if he shall be required; and the faid rents and profits shall be paid to the order of the faid commissioners, and be applied to the uses directed by this act; and in default of payment, the same shall be recovered, in the name of the faid commissioners, of any tenant or person refusing or delaying to pay the same, by the warrant of a justice of the peace, as in the case of recovering small debts before a magistrate; and the clerk of the said market shall be allowed a reasonable compensation for his services, not exceeding the sum of sisteen pounds current money by the year, to be ascertained by the faid commissioners, and to be proportionably assessed and levied upon the inhabitants and owners of property in the faid town, according to the respective valuations herein before directed to be made.

Weighers to be appointed, XX. And, whereas complaints are made of improper practices being used in the sale of sirewood and hay brought to the said town; Be it therefore further enacted. That the said commissioners, on the said first Monday of April, in the year seventeen hundred and ninety-one, and on the same day and month in every year thereaster, shall nominate and appoint two skilful and discreet persons, to be, jointly or severally, the weighers of all hay, and the corders of all sirewood, that shall be brought and sold within the said town; and if both or either of the persons so appointed shall die, resign, or resule to act, or be rendered incapable of acting by reason of mishehaviour or removal from office, the said commissioners shall assemble together as soon thereaster as conveniently may be, and nominate and appoint one or two qualified persons, as the case may be, to fill the vacancy or vacancies for the remainder of the year.

Who finall take an oath, &c.

XXI. AND BE IT ENACTED, That every person so to be appointed, before he shall proceed to execute his office, shall take an oath, or affirmation, before the said commissioners, that he will, when required, well and truly, according to the best of his skill and judgment, way hay, and cord sirewood, without savour, prejudice or partiality, either to the buyer or seller, and that he will not, directly or indirectly, ask, exact or receive, any other or greater see or reward for doing such duty, than is or shall be allowed by law; and the said oath, or affirmation, shall be administered by the said commissioners, and the taking thereof be entered among their proceedings.

Firewood to be

XXII. AND BE IT ENACTED, That from and after the faid first Monday of April next ensuing, all sirewood that shall be brought and fold, or offered for fale, in the faid town, shall be fet up in
