

VI. AND BE IT ENACTED, That if any person shall permit or suffer his chimney to catch fire, so as to blaze out of the top, such person or persons shall forfeit and pay the sum of seven shillings and six-pence current money for every such offence.

VII. AND BE IT ENACTED; That all fines and forfeitures imposed by this act, and all sums of money laid out by the commissioners of said town for the removing of nuisances, shall and may be recovered by the said commissioners before any single magistrate, in the same manner as small debts out of court, and applied to the use of said town.

C H A P. LIII.

An ACT for resurveying and laying out anew Snow-Hill-town, in Worcester county. Lib. JG. No. 1. fol. 628.

Passed 22d of Dec. 1792.

WHEREAS it is represented to this general assembly, that the plot of said town, made by virtue of an act of the general assembly passed in the year seventeen hundred and forty-two, cannot be found, and the boundaries and limits of the streets, lanes and alleys, as well as many of the lots thereof, are not known, whereby the titles of the proprietors thereof are precarious and uncertain, and it is prayed that the same may be laid out anew, which appears to this general assembly to be reasonable and proper;

II. BE IT ENACTED, by the General Assembly of Maryland, That Isaac Houston, Josiah Mitchell, James Bacon, John Gunby and John Selby Purnell, be and they are hereby appointed commissioners, who shall, on or before the first day of May next, meet at Snow-Hill-town aforesaid, and having so met, the said commissioners, or any three of them, shall have full and ample power and authority to direct the surveyor of Worcester county for the time being, to survey and make out a new and exact plot of the town, and shall ascertain and limit the extent of the lots, streets, lanes and alleys thereof, according to the best evidence that can be obtained.

Commissioners appointed, &c.

III. AND BE IT ENACTED, That the said commissioners, or any two of them, are hereby authorized and required, having first given ten days notice of the time and place of their meeting, to issue summons for such persons as may be applied for by any of the proprietors aforesaid, who are hereby required to attend, under the penalty of twenty shillings current money for every neglect or refusal, and to examine them upon oath, or affirmation, touching and concerning their knowledge of the bounds, limits and extent, of any of the lots, streets, lanes and alleys, of the said town, and to establish the same accordingly.

Who may issue summons, &c.

IV. AND BE IT ENACTED, That the said commissioners, or any two of them, shall cause the same plot, when finished, together with the depositions by them taken, to be entered on the records of Worcester county, and the same shall be thereafter considered, deemed and taken to be, the true plot of Snow-Hill-town aforesaid, and the proprietors of lots and houses in said town shall be vested with as good, sure and indefeasible estate of inheritance, in fee simple, of, in and to their several and respective lots and houses, laid down in the manner herein directed; as if the original plot had never been lost.

And cause the plot to be recorded, &c.

V. AND BE IT ENACTED, That if any one or two of the commissioners aforesaid shall die, refuse, neglect, or be rendered incapable to act, a majority of the remaining commissioners may appoint some other in place of the person who shall die, refuse, neglect, or be incapable to act; and if any three or more of the said commissioners shall die, refuse, neglect, or be incapable to act, the governor, with the advice of the council, may appoint some person or persons in his or their place or places, so as to make up the remaining vacancies in manner aforesaid.

How vacancies are to be filled.

VI. AND BE IT FURTHER ENACTED, That the said commissioners shall be allowed the sum of ten shillings per day for every day they shall attend as commissioners aforesaid; and that the surveyor shall be allowed the sum of fifteen shillings per day for every day he shall be employed by the commissioners aforesaid, for the purpose aforesaid.

Allowance to commissioners, &c.

VII. AND BE IT ENACTED, That the several proprietors of the lots in the said town shall, at their joint expence, pay to the said commissioners the aforesaid sum of ten shillings per day, to be levied on their property, to pay the said allowance to the commissioners, and all other expences, in equal proportions to the value of the property held by them severally, to be adjudged by the said commissioners.
