

C H A P. XII. **JUSTICES TO LEVY MONEY, &c.**

II. BE IT ENACTED, by the General Assembly of Maryland, That the justices of the levy court of the said county for the time being, shall and they are hereby authorized and empowered to assess and levy, in equal proportions on the property within the said county liable to assessment, at the time of laying the county rate, a sum not exceeding two hundred and fifty pounds in each of the years seventeen hundred and ninety-six, seventeen hundred and ninety-seven, and seventeen hundred and ninety-eight, together with the collector's commission of six per cent. thereon for collecting the same, which shall be collected and paid for the purposes required by the act to which this is a supplement.

Trustees appointed, &c.

III. AND BE IT ENACTED, That for the time being the several persons hereafter named be and they are hereby appointed trustees of the poor within the said county; that is to say, Messieurs Walter Smith, John Somervell, John Rawlings, Benjamin Hance, Jesse Jacob Bourne, Thomas Jenkins and Thomas H. Lyles, which persons, or the major part of them, in case of the death or absence of any of them, are hereby required, with all convenient speed, to meet at such place within their county as to them shall seem proper, to qualify themselves for the office of trustees for the poor of their county, by taking and subscribing the several oaths or affirmations required by the original law to which this is a supplement.

By an additional supplement, 1796, ch. 62, (which recites that the trustees had not acted,) the justices of the levy court are empowered to appoint others, and so to appoint in all future cases of vacancy.

Money to be levied, &c.

IV. AND BE IT ENACTED, That after the expiration of the said three years, the justices of Calvert county levy court aforesaid for the time being, shall and they are hereby empowered to assess and levy, on the assessable property in said county, at the time of laying the county rate, a sum not exceeding five shillings on every hundred pounds of property as aforesaid in the said county, together with the collector's commission for collecting the same; which said assessment shall be made, levied, collected and paid, in the same manner as is directed by the original act.

Clause, &c. to remain in force, &c.

V. AND BE IT ENACTED, That every clause, matter and thing, which is contained in the original act, not inconsistent with or repugnant to this act, shall be and remain in as full force and effect, to all intents and purposes, as if the same had been acted under at the time required thereby.

C H A P. XIII.

Passed 24th of Dec. 1795.

An ACT to survey, continue and extend, certain streets therein mentioned, lying in the additions to George-town, in Montgomery county. Lib. JG. No. 2. fol. 280.

Preamble.

WHEREAS John Threlkeld, William Deakins, junior, Uriah Forrest, Charles Beatty, George Thompson, Benjamin Stoddert, James M. Lingan, Charles Worthington, John Crookshank, James Calder, Thomas Affick, Francis Lowndes, Henry Lunt, Adam Murray Stewart, Walter S. Chandler, Joseph Forrest, Francis Lewis Taney, John Templeman, Charles Lowndes, Anthony Gofzler, John Gofzler, Isaac Dawes, Philip Abert, Theodocus Kraws, George Fenwick, Francis Neale, Bernard Medley, Robert Molineux, William Robertson and John Davidson, proprietors of certain lots in Beatty and Hawkin's addition to George-town, in Montgomery county, have, by their petition to this general assembly, prayed for the continuation and extension of First-street, Second-street, Third-street, Fourth-street, Fifth-street, Sixth-street, Seventh-street and Eighth-street, in said addition, and Fayette-street in John Threlkeld's addition to said town, as a measure of great public utility and convenience; and it appearing to this general assembly that to extend and continue the said streets will greatly contribute to the convenience of the inhabitants, and to the regularity of the town,

Commissioners appointed, &c.

II. BE IT ENACTED, by the General Assembly of Maryland, That John Templeman, Francis Lowndes and Thomas Beall, of George, be and they are hereby appointed commissioners, and they, or a majority of them, are hereby authorized and required, at sometime before the first day of August next, to cause the aforesaid streets in Beatty and Hawkin's addition to George-town to be surveyed, laid off and continued, of their present width, in straight lines, until they shall severally intersect Fayette-street in John Threlkeld's addition to George-town, and to survey, lay off and continue, Fayette-street, of its present width, until, in a straight line, it intersects High-street continued.

Who shall cause a survey to be made, &c.

III. AND BE IT ENACTED, That the commissioners aforesaid, or a major part of them, shall, on or before the said first day of August next, cause a correct and accurate survey and plot to be made of said streets, and the respective lots through which they pass, certified under the hands and seals of
