

C. H. A. P. XLIII. feitt one hundred dollars for every such offence, but such justice shall not be liable to prosecution after twelve months from the time of the offence committed.

Acts repealed. XXXIV. AND BE IT ENACTED, That the act, entitled, An act for the better administration of justice in the several counties of this state, passed at November session, seventeen hundred and ninety, \* excepting the said fourth section in the said original act, and the several supplementary acts thereto, be and the same are hereby repealed and annulled.

Duration. XXXV. This act to continue and be in force till the twentieth day of October, eighteen hundred, and until the end of the next session of assembly that shall happen thereafter.

C. H. A. P. XLIV. Passed 30th of Dec. 1796. A Further supplement to an act, (a) entitled, An act to lay out several turnpike roads in Baltimore county, and for other purposes. Lib. JG. No. 2. fol. 493.

Preamble. WHEREAS it is represented to this general assembly, that the commissioners of review of Baltimore county, appointed under the act of November session, seventeen hundred and ninety-five, \* entitled, A supplement to an act, entitled, An act to lay out several turnpike roads in Baltimore county, have not, in all instances, reviewed and confirmed the roads, as laid down under the original acts to which the above law is a supplement, and many inconveniencies have arisen to those through whose lands the said roads have been laid out, from the state of uncertainty in which the proprietors remain as to the final direction of said roads; therefore,

Commissioners to review, &c. II. BE IT ENACTED, by the General Assembly of Maryland, That the said commissioners of review, or a majority of them, shall, on or before the first Monday of September next, (b) review, and ultimately ascertain, the directions of all roads which, by the original act to which this is a further supplement, they are authorised to review, and ultimately ascertain, not heretofore reviewed and ascertained agreeably to the provisions of the original act; and when the said road or roads shall be so ascertained, a plot shall be returned thereof within two months to the county clerk of Baltimore, for the purpose of being recorded.

(b) By 1797, ch. 105, the time is enlarged to the first Monday in October, 1798, and by 1798, ch. 53, to the first Monday in October, 1799.

Make out new plots, &c. III. AND BE IT ENACTED, That the said commissioners, in case any plot or plots of road or roads laid out under the act to which this is a supplement, shall have been lost, and not returned as directed by the said act, either before or after the said road or roads had been reviewed and fixed, the said commissioners of review shall, in any manner which to them shall seem best, make out new plots, and return the same in the manner directed under the original acts to which this is a supplement; provided, that nothing herein contained shall be so construed as to authorize the said commissioners to alter the direction of any road already reviewed and confirmed, although the plot or plots thereof may, from some accident or other, have been lost.

And meet every month, &c. IV. AND BE IT ENACTED, That the said commissioners of review shall meet on the first Monday in every month, at some convenient place in Baltimore town or county, to be determined by a majority of the said commissioners; and if any commissioner shall fail to attend for three successive meetings, without a reasonable excuse, to be approved of by the commissioners attending, the said commissioners shall certify to the commissioners of the tax the name of the commissioner of review so failing to attend, and the said commissioners of the tax shall thereupon proceed to appoint a new commissioner of review in the place of the person so failing to attend as aforesaid.

Supervisors to settle, &c. V. AND BE IT ENACTED, That the supervisor or supervisors appointed by the commissioners of review, shall, in every year, on or before the first Monday in October, settle his account, on oath, with the commissioners of review, wherein shall be stated a full account of all monies received and expended by the said supervisor in virtue of his office, accompanied with all vouchers relative thereto, the said account to be exhibited to the levy court, at their annual meetings in the month of November, to be by them inspected and examined, and afterwards lodged in the clerk's office of Baltimore county.
