fied to be a member of the first branch, as elector of the mayor and of the members of the fecond branch of the city council, on the third Monday in January next, and on the fame day every lecond year thereafter; (a) who shall, on the third Monday of February, one thousand seven hundred and ninety-feven, and on the same day every second year thereaster, meet at the court-house, or some other convenient place in the faid city, and elect, by ballot, a mayor, and eight members of the fecond branch; to ferve for two years thereafter; no person shall be eligible for mayor, who is not of known integrity, experience and found judgment, twenty-five years of age, ten years a citizen of the United States, and five years a resident of Baltimore-town, or city, next preceding the election; and in case two or more persons shall have an equal number of votes for mayor, or members of the lecond branch, the faid electors shall determine, by lot, which of the persons, so having an equal number of votes, shall be appointed to the office of mayor, or second branch of the city council, as the case may require; the said electors of the mayor and of the members of the second branch, before they proceed to elect, shall swear, or affirm, as the cale may be, that they will elect, without favour, partiality or prejudice, fuch perfon for mayor, and fuch perfons as members of the fecond branch of the city council, as they in their judgment, and conscience believe best qualified for the faid offices; and having the other qualifications required by this act; that the faid electors shall be judges of the elections, returns and qualifications, of their members, but no person shall be elector of the mayor and member of the first branch of the city council at the same time; any vacancy happening in the electors of the mayor, shall be filled up from the ward where such vacancy happened, without delay, in such manner as shall be hereafter directed by ordinance, and any vacancy of the mayoralty happening, the same shall be filled up without delay by the electors of the mayor for the time being, for the remainder of the term; and all vacancies happening in the faid fecond branch. shall be filled up by the electors aforefaid.

(a) By 1797, ch. 54; the elections for elections of the mayor, and the members of the fecond branch of the city council, were directed to be held on the first Monday in October, 1798, and in every second year thereafter; and the electors of the mayor, and in every second year thereafter, for the purpose of electing a mayor and members of the second branch of the city council.

First fession to be held, &c.

VIII. AND BE IT ENACTED, That the city council shall hold their first fession at the court-house in Baltimore, or at any other place within faid city, on the fecond Monday in February, one thous fand feven hundred and ninety-feven, and they shall meet on the fecond Monday of February in every year thereafter, but the mayor may fummon them to convene whenever and as often as it may appear to him that the public good may require their deliberations; three fourths of the city council shall be a quorum to do business, but a imaller number may adjourn from day to day; they may compel the attendance of absent members, in such manner, and under such penalties, as they may by ordinance provide; they shall appoint their respective presidents, who shall preside at all their fessions, and shall vote on all questions; they shall fettle their rules of proceedings, appoint their own officers, regulate their respective sees, and remove them at pleasure; they shall judge of the elections, returns and qualifications, of their own members, and may, with the concurrence of three fourths of the whole, expel any member for diforderly behaviour, or mal-conduct in office, but not a second time for the same cause; they shall keep a journal of their proceedings, and enter the yeas: and nays on any question, resolve or ordinance, at the request of any member, and their delibers. tions shall be public; they shall afcertain, by ordinance, the compensation of their services, which, shall not be increased during their continuance in office; the fecond branch of the city council shall nominate two citizens to each office which may arise under this act, and the ordinances of faid gorporation, and the mayor shall appoint and commission one of said nomination to fill the respective offices during pleasure; and the faid mayor shall appoint proper persons to fill up all vacancies during the recess of the fession, to hold such appointment until the ensuing fession; the city council shall fettle the falary of the first mayor at their first fession of the second year, and the falary of the succeeding mayors shall be settled previously to their appointment; all ordinances or acts passed by the city council shall be sent to the mayor for his approbation, and when approved by him; shall become a law, and shall then be obligatory upon the several courts and justices of the peace of Baltimore county, sheriff and constables within the limits of the city of Baltimore, and all other persons within the limits of faid city, to every intent and purpole, as the acts of the general affembly of Maryland, provided the faid laws or ordinances shall not contain any thing repugnant to the constitution or laws of this state, or the United States; but if the said mayor shall not approve of such ordinances or acls, he shall return the same within five days, with his reasons in writing therefor, and if three fourths of both branches of the city council; on reconsideration thereof, approve of the ordinance or law, it shall then be an ordinance or law, to all intents and purposes; and if any ordinance or law shall not be returned by the mayor within five days after it shall have been presented to him, the same shall be a law, in like manner as if he had approved it, unless the city council, by their adjournment, provent its return.
