II. BE IT ENACTED, by the General Affembly of Maryland, That the justices of the peace of Anne-Arundel county, at their levy court, shall have full power and authority, and they are hereby directed and required, annually to assess, (so long as they shall see cause,) on the assessable property of faid county, a fum not exceeding twenty pounds current money for any one year, or one half of faid fum for either of them, which faid fum, so levied and affessed, shall be collected as other county charges are, and paid to the faid James Britton and Alice Britton, or either of them, as the cale may be, or fuch other person as they the said justices shall appoint, for the use, support and maintenance, of the said James Britton and Alice Britton.

C H A P. XXXI. An ACT respecting certain lots westward of Fort Cumberland erroneously transferred. Lib. JG. No 2. fol. 611.
