respective clerks shall only pay the sum of twenty-five shillings for each and every of the said blank licences as hall not be fo returned on the fettlement of their account as aforefaid.

IV. AND BE IT ENACTED, That if any of the faid clerks shall not annually apply to the treasurer Penalty for neof their respective shore for blank marriage licences on or before the said first day of May, in the steding to apmanner directed by this act, every such clerk, so neglecting or resusing to apply, shall forfeit and pay the fum of one hundred dollars for every offence.

V. AND BE IT ENACTED, That if any of the faid clerks, fo having received blank marriage And for not relicences, as herein before directed, shall refuse or neglect to return to the treasurer of their respective shore, on or before the first day of May annually, a list of all the marriage licences granted by them respectively during the preceding year, and account for and pay to the laid treasurer the fum of twenty-five shillings current money for each and every licence by them so granted, the said treasurer shall forthwith charge the clerk or clerks so neglecting or resuling with the whole amount of blank licences which shall have been before delivered to such clerk or clerks, at the said rate of twenty-five shillings for every of the said blank licences, and shall immediately thereafter profecute a fuit at law against such clerk or clerks for the same, in which it shall be sufficient to declare for so much money had and received for the use of the state, and the receipt of such clerk shall be competent evidence to entitle the state to a recovery, and a trial shall be had atthe appearance term, unless the court shall be fully satisfied that the defendant ought in justice to have an imparlance.

VI. AND BE IT ENACTED, That the governor and council shall, from time to time, cause blank Blank licences marriage licences to be printed and delivered to the faid respective treasurers, so as to keep them to be printed, provided with a sufficient number for the use of the several counties of this state in every year hereafter.

VII. AND BE IT ENACTED, That from and after the faid first day of May next, so much of the Part of an act act, (a) entitled, An act concerning marriages, as directs a different mode of granting and account- repealed, &c. ing for marriage licences, be and the same is hereby repealed; provided nevertheless, that until the faid day the respective clerks shall issue licences of marriage in the manner directed by the said act, and shall then account to the respective treasurers for all licences by them granted before the said day, and fince their last returns. C H A P. XXXIX.

An ACT for the benefit of Nicholas Slubey, merchant, of the city Paffed 20th of of Baltimore. Lib, JG. No. 2. fol. 626.

WHEREAS it is represented to this general assembly, by the petition of Nicholas Slubey, of Preamble.

Baltimore county, that by a variety of losses and misfortunes in trade Baltimore county, that by a variety of losses and misfortunes in trade as a copartner with Joseph Smith, of Great-Britain, he has been rendered unable immediately wholly to satisfy the debts for which he is answerable; and that a part of his creditors are resident in foreign countries, and have become bankrupt, whereby affent to his release cannot be obtained; and that others of his foreign creditors have no known agents in the United States; and that from the peculiarity of his fituation, it would be attended with loss and damage to his creditors, as well foreign as domestic, to require the affent of foreign creditors, or their agents, to his release; and the faid representation appearing to the legislature to be true,

II. BE IT ENACTED, by the General Assembly of Maryland, That upon the application of the faid Chancellor, on Nicholas Slubey to the chancellor, by petition in writing, offering to deliver up all his estate, in application, to direct notice, possession or remainder, for the benefit of his creditors, and annexing to the said petition &c. a schedule of his property and debts, the said schedule comprehending distinct and separate lists of all the property and debts belonging to him in his own right, and of all property and debts belonging to his copartnership, and a list of his creditors, so far as he can ascertain the same, on oath, the chancellor shall direct notice of such application to be given, and published in such manner as he shall think expedient, and appoint a certain day for the creditors of the faid Slubey to appear in the chancery court to recommend a trustee or trustees on their behalf, and on the appearance of the said creditors, or on their neglect to appear on notice as aforefaid, the chancellor shall administer to the faid Nicholas Slubey the following oath; "I, Nicholas Slubey, do fwear, that I will deliver up, "convey and transfer, to my creditors, in fuch manner as the chancellor shall direct, all my property "that I have or claim any title to, or interest in, at this time, and all debts, rights, claims and " credits.
