C.H.A.P. LXXXV. Commissioners appointed, &c.

II. BE IT ENACTED, by the General Assembly of Maryland, That Messeurs William Morris, Elisha Purnell and James Houston, be and are hereby appointed commissioners for the purposes of this act; and the said commissioners, or a majority of them, are hereby authorised to open and clear, at least twenty seet wide, the said road, and the said road, so opened and cleared, (after the valuation herein after directed to be made, or the damages herein after directed to be allessed, shall be paid or secured to the individuals concerned,) shall be recorded among the records of Worcester county, and shall for ever thereafter be deemed a public road, and shall be kept in repair in the same manner as other public roads are kept in said county.

Damages to be afcertained, &c.

III. AND BE IT ENACTED, That the commissioners aforesaid, or a majority of them, shall ascertain and value what damages may be sustained by any person or persons through whose lands the said road may pass by opening and clearing the same, and the said valuation shall be made and paid before the commissioners shall proceed to open and clear the same; and in case any proprietor or proprietors shall conceive him, her or themselves aggrieved by the valuation of the said commissioners, or shall be an infant, feme-covert, or non compos mentis, it shall and may be lawful for the faid commissioners. on the application of any person interested, to apply to any justice of the peace for Worcester county, who shall thereupon issue his warrant, under hand and seal, to the constable of the hundred wherein fuch lands may be, commanding him to fummon twelve freeholders, difinterested in the said road, and not related to the owner or owners, to appear on a day by him to be appointed on the faid lands, at which time such freeholders, so summoned, shall respectively appear before such justice, and take the following oath, or affirmation, viz. "I, A. B. do Iwear, or affirm, that I will honeftly " value the damage and injury sustained by C. D. by opening a road through the lands of the said " C. D. in pursuance of this act, having regard to all the conveniencies and disadvantages attending the fame;" and shall return an inquisition of such damages by them affested to the clerk of the county court of Worcester, and the damages so assessed shall be conclusive.

To be paid to commissioners, &c.

IV. AND BE IT ENACTED, That the persons who may conceive themselves interested or benefitted by said road, are hereby required to pay into the hands of the commissioners aforesaid, for the use of the person or persons in whose favour such valuation may be made, immediately upon laying out the road aforesaid, whatever damages be as aforesaid adjudged to the party sustaining such damages, and in case of failure of payment as aforesaid, this act to be null and void, but in case of compliance with the provisions of this act, the said road to be considered a public road, and to be kept up as other public roads in said county.

Preamble.

WHEREAS it is represented to this general assembly, that the trustees in the said act mentioned ed took upon themselves the trust by the said act reposed in them, and according to the directions of the said act did make sale of the lands therein mentioned; and that all the trustees in the said act mentioned are since dead, except Thomas Sim Lee, Esquire, and the before-mentioned Sarah Buchanan, who hath since intermarried with a certain Robert Turnbull, of the commonwealth of Virginia: And whereas by a supplement to the said act, the aforesaid Thomas Sim Lee was authorised to execute and acknowledge to the purchaser or purchasers of the said lands, on the purchase money for the said property so told being paid, a deed or deeds, conveying the said property to the said purchaser or purchasers in see: And whereas the said Thomas Sim Lee hath declined to execute a deed to one of the purchasers of the said lands, who had paid the whole of the purchase money for the lands by him purchased, and it being requisite that when the purchase money is paid, some person should be authorised and empowered to execute deeds for the said lands,

Chancellor to execute a deed, &c.

II. BE IT ENACTED, by the General Assembly of Maryland, That the chancellor of the state for the time being be and he is hereby authorised and empowered, on the purchase money for the said property so fold being paid, to execute and acknowledge to the purchaser or purchasers of the same a deed or deeds, conveying the said property to the said purchaser or purchasers in see, which deed or deeds.
