mitilithe whole recording be completed, feverally make out a fair and accurate account of the fervices by them respectively performed, in pursuance of this act; and the account of the said clerk, when examined and paffed by the faid chief justice, and the account of the faid reguler, when examined and palled by the justices of the faid orphans court, or a majority of them, shall be by them certified, under their respective hands and seals, and transmitted to the justices of the levy court of Queen-Anne's county, who shall, at their next meeting for the purpose of laying the county levy, after receiving fuch accounts, affels and levy upon the affelfable property in faid county a fum of money, exclusive of the commission now allowed by law for collecting the same, sufficient to discharge the said accounts, and cause the same, when collected, to be paid to the said clerk and register respectively.

VI PROVIDED NEVERTHELESS, AND BE IT ENACTED, That no compensation shall be made by the Provise. faid county to the faid clerk or register of wills for recording any papers that shall have been depolited and filed in either of the laid offices fince the appointment of the laid clerk or regilter to their faid respective offices; and provided also, that no judgment shall be recorded in virtue of this act.

VII. AND BE IT ENACTED, That it shall and may be lawful for the justices of the levy court of Justices to Queen-Anne's county, and they are hereby authorifed and required, to make such allowance to the make allowfaid chief justice as they may think an adequate compensation for the services by him rendered in pursuance of this act, and to cause the same to be assessed and levied upon the assessable property in the faid county.

VIII. AND BE IT ENACTED, That this act shall continue in force until the fifteenth day of April, Duration. in the year eighteen hundred and one, and no longer.

EIT ENACTED, by the General Affembly of Maryland, That all'real and personal property in this Property to be D state, except property belonging to this state, or the United States, houses for public worship, valued, &c. burying-grounds, or property belonging to any county, or to any college, or to any county school, and except also the crop and produce of the land in the hands of the person whose land produced the same, and provisions necessary for the use and consumption of the person to whom the same shall belong, and his family, for the year, and plantation utenfils, the working tools of mechanics and manufacturers, actually and constantly employed in their respective occupations, wearing apparel, goods, wares and merchandife, and all home made manufactures in the hands of the manufacturers, all stills, all ready money, all grain and tobacco, all licenfed veffels whatever above twenty tuns burthen, and all riding carriages, shall be valued agreeably to the directions of this act, and shall be chargeable according to such valuation with the public assessment.

II. AND BE IT. ENACTED, That five fensible, discreet and experienced persons, shall be appointed Commissioners in each county of this state, who shall be called Commissioners of the Tax, and they, or any three ed, &c. or more of them, shall be the commissioners for the county for which they shall severally be appointed; and five persons as aforesaid shall be appointed, and called Commissioners of the Tax for the City of Bultimore, for the same time; provided, that no clergyman, practifing attorney or physician, theriff, clerk of the general or any county court, ordinary-keeper, mariner or inspector, shall be appointed a commissioner or assessor.

III. AND BE IT ENACTED, That the following persons shall be and are hereby appointed commission.
