an act of assembly, entitled, An act to alter and repeal those parts of the constitution and form of CHAP. government that make the commissioners of Baltimore-town judges of the elections for delegates and for elector of the fenate, was passed, to alter and repeal those parts of the constitution and form of government that are therein mentioned: And whereas the faid act of affembly hath been published in due form for the space of three months next before the late general election of delegates to the house of delegates, secording to the provisions of the said form of government, and this general assembly hereby intend to confirm the said act,

An act confirmed.

II. BE IT ENACTED, by the General Assembly of Maryland, That the said act, entitled, An act to alter and repeal those parts of the conflitution and form of government that make the commissioners of Baltimore-town judges of the elections for delegates and for elector of the senate, be and it is hereby confirmed and made valid to every intent and purpose therein mentioned.

C H A P. III.

Passed 15th of Jan. 1799.

An ACT to authorife and empower the levy court of Baltimore county to affels and levy annually a fum of money for the support of Honour Bosley, an idiot, of Baltin re county. Lib. JG. No. 3. iol. 18.

Preamble.

WHEREAS it is represented to this general assembly, by the petition of Rachel Bolley, of Baltimore county, that she is a widow, and has a daughter an idiot, now near forty years of age, and that she is entirely unable to support herself and daughter, and praying that an act may pals for the support and maintenance of her said daughter; and the prayer of the petitioner appearing reafonable, therefore,

II. BE IT ENACTED, by the General Affembly of Maryland, That the justices of the levy court for the point a guardi- time being for Baltimore county shall and they are hereby authorised and empowered to appoint Rachel Bolley guardian or trustee, or any other person they may think proper, for the purpose of receiving, and applying to the use and support of Honour Bosley, an idiot, whatever sum of money may be by the justices of the levy court of Baltimore county assessed and levied as hereafter directed.

And levy money, &c.

III. AND BE IT ENACTED. That the justices of the levy court for the time being of Baltimore county shall and they are hereby authorised and empowered to assess and levy annually on said county the fum of twenty dollars for the support and maintenance of the aforesaid Honour Bosley, and that the same be collected and paid to her guardian or trustee by the collector or collectors of Baltimore county, agreeably to the order of the levy court aforefaid, and paid over to her faid guardian or trustee on or before the first day of November in each year.

Proviso.

IV. PROVIDED ALWAYS, AND BE IT ENACTED, That the justices aforesaid, before they grant the faid allowance, shall be fatisfied that the faid Honour Bosley is an idiot at the time of granting such allowance.

CHAP.

A Supplement to the act, * entitled, An act for the destruction of wolves in Allegany county. Lib. JG. No. 3. fol. 19.

Preamble.

THEREAS it is represented to this general assembly, that wolves are very numerous and mischievous in the county aforesaid, and that they destroy a great number of sheep; therefore,

Justices to give

II. BE IT ENACTED, by the General Affembly of Maryland, That when and as often as any credible accrificate, ac. person or persons shall bring before any justice of the peace for Allegany county the head or heads of any wolf or wolves, and make oath, or affirmation if a quaker, menonist or tunker, that the wolf or wolves of which he or they produce the head or heads were actually caught and killed within the limits of Allegany county within fix days next before the producing of the same to such justice, that then such justice shall and he is hereby authorised and directed to give such person or persons producing the same a certificate for such head or heads produced and proved as aforesaid, and in such certificate to mention the oath or affirmation taken, and therein diftinguish how many of the heads are of old or young wolves; and every justice who shall have any wolves head or heads brought before him by any person or persons as aforesaid, shall be and he is hereby authorised and empowered to judge of the age of the faid wolf or wolves of which the faid head or heads was brought before him, and
