Preamble.

WHEREAS it is represented to this general assembly, by the petition of the trustees of the poor of Calvert county, that the sum levied for erecting an alms-house in their county is inadequate for said purpose; therefore,

II. BE IT ENACTED, by the General Assembly of Maryland, That the justices of the levy court of the said county for the time being shall and they are hereby authorized and empowered to assess and levy on the property within the said county liable to assessment, at the time of laying the county rate, a sum not exceeding two hundred pounds in each of the years seventeen hundred and ninety-nine, and eighteen hundred, together with the collector's commission of six per cent. thereon for collecting the same, which shall be collected and paid for the purposes required by the act to which this is a further supplement.

III. AND BE IT ENACTED, That the trustees of the poor for said county be authorized to pay, out of the money so to be levied, the sum of sixty dollars as a compensation to the clerk whom they have employed to keep an account of their proceedings.
