ACADEMY.

An academy established at Lower-Marlborough, in Calvert county. October, 1778, ch. 16.
Washington academy established on Back creek, in Somerset county. November, 1779, ch. 15.
An annual donation thereto by the state of eight hundred dollars. 1798, ch. 107, § 3.
The same donation made to trustees for an academy to be established in Talbot county. *Ibid.*
An academy established at Easton, in Talbot county. 1799, ch. 56, § 1.

ACCEPTANCE.

ACCOUNTS.

Manner of proving accounts not exceeding ten pounds in any year. 1729, ch. 20, 1785, ch. 46, § 8.

In what manner accounts in bar may be filed or pleaded, and discounted from the plaintiff's claim. *Ibid.* § 7.
Provision for auditing accounts and dealings between the parties to a suit. 1785, ch. 80, § 12.
Accounts which concern the trade and merchandise between merchant and merchant, their factors and servants, not residents in the state, excepted out of the act of limitation. 1715, ch. 23, § 2.
