A company established for building a bridge over Anacostia river on the Eastern Branch, by the name of the Anacostia Bridge Company. 1797, ch. 92.

## ANNAPOLIS.

To be the chief place and seat of justice, &c. 1699, ch. 19.  
The charter granted on the 22d of November, 1708, to erect Annapolis into a city and corporation, confirmed under certain restrictions. 1708, ch. 7.

King William school established. 1696, ch. 17.

Regulations respecting the same. 1774, ch. 15.

The funds thereof consolidated with those of St. John's college. 1785, ch. 39.

Commissioners appointed to determine disputes concerning lots. 1718, ch. 19.

The titles to lots in the addition thereto, or adjoining, confirmed. 1725, ch. 7.

Probats of deeds, &c. may be made in the mayor's court, or before two of the magistrates, and deeds of lands within the precincts acknowledged before them are valid. 1725, ch. 8.

Ground appropriated for building a custom-house and market-house. 1728, ch. 9.

An act for building a public gaol there. 1736, ch. 6.

Directions for leasing out the church lots. 1747, ch. 24.

A new church to be built therein. 1774, ch. 11.

The trustees empowered to proceed, &c. 1785, ch. 44.

Materials taken away to be paid for by the state, and the trustees empowered to recover from other persons, and to recover the subscriptions. May, 1788, ch. 16.

Invested with the power of regulating ordinaries and retailers of spirituous liquors therein, and granting licences therefor. 1784, ch. 49.

Directions for the application of the said tax, licence money, &c. *Ibid.* § 4.

The corporation enabled to sell or lease certain lands. June, 1777, ch. 3.

The jurisdiction of the mayor's court enlarged, &c. *Ibid.*

The corporation enabled to sell certain streets. November, 1779, ch. 11.

Empowered to appoint port-wardens, for the regulation of wharfs. 1785, ch. 26.

Public ground in the city, (four acres,) granted by the state to St. John's college, in case the city of Annapolis should be fixed on as a proper place for establishing the said college. 1784, ch. 37, § 7.

Commissioners appointed for building a new prison. 1785, ch. 73.

The corporation empowered to prevent public and excessive gaming. 1790, ch. 46.

The extent of the precincts declared. *Ibid.*

Empowered to fine, imprison or punish, vagrants, free negroes, &c. 1796, ch. 30.

Such persons may be sold for a term not exceeding four months for their prison fees. *Ibid.*

## ANNAPOLIS.

The burning and disposition of bricks regulated. 1791, ch. 49.

The city of Annapolis ought to have all its privileges, &c. agreeable to its charter, and the acts confirming the same, subject to alterations by the convention or a future legislature. Decl. 37.

All persons qualified by the charter of the city of Annapolis to vote for burgesses, empowered to elect two delegates qualified by the said charter. Conf. 4.

Manner of holding and judging of the said elections. *Ibid.*

The inhabitants of Annapolis not entitled to vote for delegates for Anne-Arundel county, unless they have a freehold of fifty acres of land, distinct from the city. *Ibid.*

Anne-Arundel county, including the city of Annapolis, to be laid off into five separate districts, for the purpose of holding elections. 1798, ch. 115, confirmed by 1799, ch. 48.

Commissioners appointed to lay off the said districts, and to fix the place of holding the elections in each. 1799, ch. 50, § 20.

Prince-George's and Anne-Arundel counties, (including the city of Annapolis,) form the second district for the election of representatives in congress. 1791, ch. 62, § 1.

Anne-Arundel county, (including the city of Annapolis,) and Baltimore town, form the fifth district for appointing electors to choose the president and vice-president. 1795, ch. 73, § 1.

The act for the preservation of the breed of wild deer not to extend to Anne-Arundel county. 1789, ch. 5, § 5.

The executrix of Benjamin and Joseph Howard empowered to appoint a person to collect the balances due to Benjamin Howard, former collector of the taxes. 1791, ch. 36.

The salaries of the inspectors of tobacco at Elk-Ridge Landing warehouse to be increased. *Ibid.* ch. 46.
