

BALTIMORE.

— The court to be held on the second Monday in January, the first Monday in March and August, and the third Monday in November; in every year. *Ibid.* § 3.

The levy court empowered to licence the erection of an additional warehouse for the inspection of tobacco in the city of Baltimore. *Ibid.* ch. 87, § 3.

Anne-Arundel, Baltimore and Harford counties, form the third district for holding county courts. 1796, ch. 43, § 2.

— Baltimore county court to be held the first Monday in April and September. *Ibid.* § 3.

Baltimore-town to choose two delegates to the general assembly. Const. 5.
