

**FINES AND FORFEITURES.**

On sheriffs neglecting to deliver such warrants, 1000 lbs. tobacco. *Ibid.*

For excessive usury, the treble value of the money, &c. contracted, (sent on bargain) for. *Ibid.* ch. 69, § 3.

For breaking open private letters, *L. 5.* 1713, ch. 2, § 8.

For breaking open public letters, *L. 20.* *Ibid.* § 9.

For selling by any dry measure, not stamped at the standard, 500 lbs. tobacco. 1715, ch. 10.

For buying by such dry measure, if prosecuted within one year, *L. 5.* November, 1765, ch. 1.

For shooting, hunting, or carrying a gun on any seated plantation by persons convicted of, thieving or hog-stealing, or being of evil fame, 1000 lbs. tobacco. 1715, ch. 26, § 7.

On persons committing adultery, *L. 3.* or 1200 lbs. tobacco. *Ibid.* ch. 27, § 3.

On justices of the peace, sheriffs and deputy sheriffs, clerks or deputy clerks, pleading as attorneys, 3000 lbs. tobacco. *Ibid.* ch. 41, § 9.

For dealing with servants or slaves without leave, 2000 lbs. tobacco. *Ibid.* ch. 44, § 11.

On sheriffs demanding bail bonds to a greater amount than is therein mentioned, 4000 lbs. tobacco. *Ibid.* ch. 46, § 3.

On attorneys issuing criminal process from the general court without presentment or order as therein mentioned, 5000 lbs. tobacco. *Ibid.* ch. 48, § 1.

In the county courts, 2500 lbs. tobacco. *Ibid.* § 2.

On clerks of the general court so issuing, 5000 lbs. tobacco. *Ibid.* § 3.

On clerks of the county courts, 2500 lbs. tobacco. *Ibid.*

On clerks delivering blank writs, 5000 lbs. tobacco. *Ibid.* § 11.

On jurors giving more to a jury than is therein directed, in the general court, not exceeding 6900 lbs. tobacco. 1719, ch. 37, § 2.

On attorneys neglecting their duty as therein stated to the prejudice of their clients, in the general court, 5000 lbs. tobacco. 1721, ch. 14, § 2.

On persons cutting down or otherwise destroying any boundary or boundary trees, 5000 lbs. tobacco. 1722, ch. 8, § 2.

On persons setting up boundaries otherwise than is therein expressed, 5000 lbs. tobacco. *Ibid.* § 3.

On sheriffs or their deputies omitting to read the act to prevent the tumultuous meetings of slaves, &c. at every county court, 500 lbs. tobacco. 1723, ch. 15, § 8.

On housekeepers selling any strong liquor on Sundays, (except in cases of absolute necessity,) or suffering any drunkennells gaming, &c. if prosecuted within six months, 2000 lbs. tobacco. *Ibid.* ch. 16, § 11, 15.

On sheriffs refusing to discount debts due from them out of any public dues, &c. 2000 lbs. tobacco. 1724, ch. 21, § 4.

On clerks of courts or registers refusing to deliver to defendants, if required, full copies of all costs recovered against them, 2000 lbs. tobacco. 1731, ch. 15, § 8.

For uplading ballast contrary to the provision therein contained, *L. 50.* 1734, ch. 16, § 2.

For building weirs or hedges contrary thereto, *L. 10.* *Ibid.* § 3.

On persons setting up barrels for pork, &c. of less size than herein directed, for every barrel 2/6. 1745, ch. 15, § 3.

Packing pork or beef in less quantities than herein prescribed, for every barrel 10/6. *Ibid.* § 4.

Selling barrels of pork, &c. of less size or quantity, for every barrel 10/6. *Ibid.* § 5.

On clerks or registers removing from their offices any books, &c. and suffering them to be kept out between eleven at night and six in the morning, *L. 10.* 1747, ch. 3, § 10, 1748, ch. 7.

On persons entertaining servants or slaves, for every hour 100 lbs. tobacco. 1748, ch. 19, § 2.

If exceeding 600 lbs. tobacco, to be recovered in the county court. *Ibid.*

On sheriffs for not reading the act for the more effectual punishment of negroes, &c. as therein directed, *L. 5.* 1751, ch. 14, § 11.

On persons not making causeways and bridges over branches where mills are built, on which public roads cross, *L. 20.* 1753, ch. 16, § 2.

For not making causeways, &c. over branches below such mills, *L. 20.* 1756, ch. 19.

For marrying within the three degrees of lineal consanguinity, or within the first degree of collateral consanguinity, *L. 500.* February, 1777, ch. 12, § 2.

For marrying within any other of the degrees of kindred, or within the degrees of affinity therein expressed, *L. 200.* *Ibid.* 1785, ch. 35, 1790, ch. 20.

For celebrating the rites of marriage, (unless by ministers of the church of England, dissenting ministers, Romish priests, or in such manner as has been practised by the society of quakers,) *L. 500.* February, 1777, ch. 12, § 3.

On ministers for celebrating the rites of marriage between persons related within the degrees above mentioned, *L. 500.* *Ibid.* § 4.

On persons marrying in the state without a licence or publication, *L. 500.* *Ibid.* § 5.
