

## FINES AND FORFEITURES.

On ministers joining in marriage any male person under the age of 21, or any female under the age of 16, (and not before married,) without the consent of the parent or guardian personally given, or signified under hand and seal, and attested by two witnesses, £. 500. *Ibid.* § 9.

On ministers wilfully publishing the bands of marriage between servants, or between free persons and servants, or wittingly celebrating marriage between any such, without leave of their master or mistress, £. 50. *Ibid.* § 11.

On clerks omitting to deliver to the governor and council yearly, on or before the 15th of December, lists of fines, &c. in their courts, £. 200. *Ibid.* ch. 13, § 4.

Fines imposed under the act to punish certain crimes and misdemeanors, and to prevent the growth of intemperance. *Ibid.* ch. 20.

Fines on officers taking greater fees than are therein limited, £. 50. November, 1779, ch. 25, § 1.

On registers of wills for demanding or receiving any fee, gratuity, &c. for giving their services in any thing relating to their offices, £. 50. *Ibid.* § 7.

On officers named in this act omitting to take the oath therein prescribed, £. 150. *Ibid.* § 8.

On deputies and under clerks refusing or neglecting to take the oath therein prescribed, £. 100. *Ibid.* § 9.

For keeping ordinaries before suppressed without licence first obtained, for every month, 1000 lbs. tobacco. *Ibid.* § 9.

For neglecting to keep sealed measures, and refusing or neglecting to sell by such, 600 lbs. tobacco. *Ibid.* § 10.

On persons not licensed selling any spirituous liquor, mixed or unmixed, and suffering any part to be drank in or about their houses or plantations, 600 lbs. tobacco. *Ibid.* § 11.

For selling such liquors at or near the court-houses, 600 lbs. tobacco. *Ibid.*

At or near the place of any muster or training of militia, 600 lbs. tobacco. *Ibid.*

For selling such liquors on board any vessel, and suffering the same to be drank therein, except to sailors, &c. 600 lbs. tobacco. *Ibid.*

On licensed persons for selling liquor at horse-races after sunset, 800 lbs. tobacco. *Ibid.* § 15.
