

FINES AND FORFEITURES.

On the inspectors of pot and pearl-ash, who, during their continuance in office, shall vend, barter, or trade in those articles, £. 100. *Ibid.* ch. 63, § 2.

— On persons shipping or receiving pot or pearl-ash not inspected and marked, &c. or having the marks counterfeited, or that has been condemned, £. 25. *Ibid.* § 6.

— On persons marking any cask containing pot or pearl-ash, or altering the marks of the inspector, £. 50. *Ibid.*

— On persons resisting the inspector in searching suspected vessels, £. 20. *Ibid.* § 7.

On masters neglecting to lodge indentures of apprenticeship with the registers of the orphans courts within thirty days, £. 3. 1793, ch. 45, § 4.

— On trustees of the poor taking such indentures and neglecting so to lodge them, £. 3. *Ibid.* § 5.

On an apprentice being fined, the court shall adjudge the time which he shall serve his master, on his paying the fine for him. *Ibid.* § 10.

Persons harbouring apprentices to suffer the same penalties as the harbourers of servants. *Ibid.* § 16.

For altering, changing, obstructing or encroaching upon, any of the roads therein mentioned, or cutting down or destroying any of the bridges, boundaries, &c. not exceeding £. 50. 1794, ch. 52, § 14.

On county clerks neglecting to transmit annually, within one month after the county assessment, a copy thereof to the governor and council, £. 50. *Ibid.* ch. 53, § 2.

— On their neglecting to deliver, within ten days after the assessment, a copy to the collector, £. 200. *Ibid.*

On persons making wrears, or falling trees across Pocomoke river or canal, £. 10. 1796, ch. 17, § 20.

On persons whipping or beating the water in Patuxent river contrary to this act, 100 dollars. *Ibid.* ch. 32, § 2.

— On the masters of slaves so offending, 20 dollars. *Ibid.* § 3.

— On justices of the peace not accounting for money received under this act, 200 dollars. *Ibid.* § 4.

On associate justices and justices of the peace taking greater fees than are there allowed, 100 dollars. *Ibid.* ch. 43, § 33.

On persons forcibly or fraudulently carrying, or causing to be carried out of this state, any free negro or mulatto, knowing such negro or mulatto to be free, 800 dollars. *Ibid.* ch. 67, § 15.

— On persons so carrying, or causing to be carried, out of the state, any negro or mulatto entitled to freedom at a certain age, and there selling, or causing such negro, &c. to be sold as a slave for life, or for a longer time than he has to serve by law, knowing him to be so entitled, 800 dollars. *Ibid.* § 16.

— On persons bringing into this state negroes, &c. so entitled to freedom at a certain age, and selling them, &c. as in the preceding article, 800 dollars. *Ibid.* § 17.

On free negroes or mulattoes giving or selling their certificates of freedom to any slave to enable him to abscond from his master, not exceeding 300 dollars. *Ibid.* § 18.

— On persons giving a pass to any slave or person held to service, or assisting their transportation, or by other unlawful means depriving the owners of their services, 200 dollars. *Ibid.* § 19.

On county clerks issuing marriage licences contrary to the act to secure the duties on them, 50 dollars. 1797, ch. 38, § 1.

— Neglecting to apply annually to the treasurer for blank marriage licences on or before the first of May, 100 dollars. *Ibid.* § 4.

On registers of wills taking greater fees than are therein limited, 150 dollars. *Ibid.* ch. 76.

On sheriffs and coroners neglecting to take the oath or affirmation therein prescribed, and to return a certificate thereof, 50 dollars. *Ibid.* ch. 87, § 2.

On assessors neglecting to return to the commissioners of the tax certificates for the valuation of real and personal property in their district, not exceeding £. 50. *Ibid.* ch. 89, § 10.

— On persons refusing, or after reasonable notice neglecting, to give an account of their property to the assessor, not exceeding £. 50. *Ibid.* § 15.

— On persons removing their property to escape being assessed, £. 50. *Ibid.* § 20.

— On the commissioners failing to meet as therein directed to hear appeals from the valuation of assessors, not exceeding £. 20. *Ibid.* § 21.

— Neglecting to deliver to the sheriffs summary accounts of personal property, to be forwarded to the clerk of the house of delegates, each, £. 50. *Ibid.* § 27.

— On sheriffs neglecting to forward the same as public letters, £. 50. *Ibid.*

— On persons removing who refuse to give an account thereof to the collector or his deputy, not exceeding £. 50. *Ibid.* § 30.

On persons setting up or keeping E. O. A. B. C. L. S. D. or faro tables, or other devices, (except billiard tables,) for the purpose of gaming for money, in any dwelling-house, &c. occupied by a tavern-keeper, retailer, &c. whether licensed or not, £. 50. *Ibid.* ch. 110, § 2.

For maliciously setting on fire any woods, fences, &c. in the counties therein mentioned, not exceeding 100 dollars. 1798, ch. 39, § 2.

On persons purchasing, leasing, &c. from the Indians, the lands therein mentioned in Dorchester county, 200 dollars. *Ibid.* ch. 82, § 10.

On persons, not already practitioners of medicine or surgery, practising and receiving payment without a licence certified as therein prescribed, 50 dollars. *Ibid.* ch. 105, § 6.

On persons keeping for use a billiard table without obtaining a licence as directed by this act, 150 dollars. *Ibid.* ch. 113, § 3.

— On persons omitting to renew their licences, and keeping open their billiard tables, 150 dollars. *Ibid.* § 2.

— On county clerks omitting to lay before every session of the levy court a return of the sums received under this act, 50 dollars. *Ibid.* § 5.

On persons holding any office of profit or trust under the government of the United States, or whose office under this state shall be vacated by the late provisions of the constitution, who shall, after the 1st of March, 1800, execute any office under this state, not exceeding 100 dollars. 1799, ch. 68.

On persons after the 1st of April, 1800, keeping ferry without licence, 50 dollars. *Ibid.* ch. 83, § 4.

On clerks or sheriffs neglecting to make out and deliver warrants to the judges of elections, 50 dollars. *Ibid.* ch. 50, § 3.
