

FREDERICK COUNTY.

Nothing in this act to prevent persons in Frederick county from carrying their tobacco to any public warehouse on navigable water. 1790, ch. 55, § 10.

A market to be established for the sale of live stock at Westminster-town, in Frederick county. 1794, ch. 9.

Washington, Frederick, Montgomery and Allegany counties, form the fifth district for holding county courts. 1796, ch. 43, § 2.

Frederick county court to be held the third Monday in March and November. *Ibid.* § 3.

Montgomery county, and that part of Frederick county adjacent as far as Monocacy, from the mouth thereof to the Pennsylvania line, form the third district for the election of representatives in congress. 1791, ch. 62, § 1, 2.

The remainder of Frederick county, Washington and Allegany counties, form the fourth district. *Ibid.*

District polls to be kept for the different districts in the county. *Ibid.* § 3, 1799, ch. 76.

Frederick county forms the third district for appointing electors to choose the president and vice-president. 1795, ch. 73, § 1.

Frederick county to be laid off into seven separate districts for holding elections. 1798, ch. 115, confirmed by 1799, ch. 48.

Commissioners appointed to lay off the said districts, and to fix the place of holding the elections in each. 1799, ch. 50, § 20.

The average value of lands established in Frederick county at 27s. per acre. 1785, ch. 53, § 2.

Frederick county school founded in Frederick-town, in the said county. 1796, ch. 65.

FREDERICK-TOWN.

A market established and regulated, November, 1770, ch. 4.

FREEDOM.

No petition for freedom shall originate in the general court, but in the county where the petitioner resides, under the direction of his owner. 1796, ch. 66, § 21.

The process to be issued to the county where the owner resides. *Ibid.*

Things annexed to the free-hold which may be removed without prejudice are assets. 1798, No. 101, ch. 7.

FREE NEGROES.

Penalty for transporting them, &c. 1796, ch. 67, § 15, 16.

On free negroes giving or selling their certificates of freedom. *Ibid.* § 18.

If living idle, and without means of subsistence, they may be obliged to give security, or be imprisoned. *Ibid.* § 20.

FUNERAL EXPENSES.

To be allowed to executors or administrators at the discretion of the orphans court, according to the condition, &c. of the deceased, not exceeding 300 dollars. 1798, No. 101, ch. 10, § 2.

GAMING.

THE corporation of Annapolis empowered to make ordinances to prohibit public and excessive gaming in the city and its precincts. 1790, ch. 46.

Persons setting up any E. O. A. B. C. L. S. D. or faro table, or other device, (except billiard tables,) for the purpose of gaming, in any dwelling or place occupied by a tavern-keeper or retailer of spirituous liquor, forfeit such tables and £. 50 for every offence, to be recovered by indictment. 1797, ch. 110, § 2.

On conviction thereof the licence of such tavern-keeper, &c. to be void. *Ibid.* § 3.

Any justice empowered to suppress and prevent the playing at such tables. *Ibid.* § 4.

One half of the fine to the persons informing, and the other to the county, the inhabitants of which shall notwithstanding be admitted as witnesses. *Ibid.* § 5.

This act not to affect the chartered rights of Annapolis or Baltimore. *Ibid.*

GAUGE or BARRELS.

The size of barrels for the exportation or sale of pork, pitch, &c. prescribed. 1745, ch. 15, § 2.

The contents of such barrel for pork or beef to be 220 lbs. well preserved, &c. *Ibid.*

For turpentine or pitch, to be clean and merchantable. *Ibid.* § 3.

Penalty on setting up barrels of a less size, &c. than directed by this act. *Ibid.*

On packing pork or beef in barrels or quantity contrary thereto. *Ibid.* § 4.

On bartering or selling pork, tar, &c. contrary thereto. *Ibid.* § 5, 6.

On importing and offering the same for sale. *Ibid.* § 7.

Penalty on offering flour or bread for sale without marking the tare on the bulge. *Ibid.* § 8.

Mode of recovering penalties, and time limited for bringing actions. *Ibid.* § 9, 10, 11.

GARNISHEE.

May plead a condemnation and execution on attachment in bar of any suit brought by the defendant therein. 1715, ch. 40, § 3, 7.

A garnishee may, to every attachment under this act, plead in behalf of the defendant such plea or pleas as the defendant might or could do if he had been taken and had appeared. 1795, ch. 56, § 4.
