

MINISTERS.

Every gift, sale, or devise of lands, to any minister as such, and every devise of goods or chattels to or for the support of any minister as such, declared void, without the leave of the legislature. Decl. 34.

No minister of the gospel, or preacher of any denomination, shall have a seat in the general assembly or in the council of the state. Const. 37.

Ministers of the gospel, regularly ordained or licensed by any religious society, exempted from militia duty. 1793, ch. 53, § 11.

Clergymen shall not be commissioners of the tax or assessors. 1797, ch. 89, § 2.

The rector of each parish to preside in the vestry. 1798, ch. 24, § 8.

To have (unless the contract's otherwise,) the possession and use of the glebe-lands and other property belonging to the parish, while he officiates therein. *Ibid.*

On committing waste he shall pay treble damages, which may be recovered by the vestry. *Ibid.* § 10.

The vestry empowered to choose one or more ministers or readers of the protestant episcopal church to officiate as long as such vestry may think proper, and to contract with them for their salaries, the use of the glebe, &c. *Ibid.* § 15.

Empowered to take in subscription for such minister or reader. *Ibid.* § 17.

The principal of the money arising from sales of church property not to be applied towards the payment of the minister. *Ibid.* § 30.

Directions as to the titles and precedence of the ministers. *Ibid.* § 16.

The ministers to take care that the registers be made acquainted with all baptisms, marriages and funerals, celebrated by them in their parishes. *Ibid.* § 19.

On their being celebrated by them in any other parish, they shall acquaint the minister or a vestryman thereof. *Ibid.* § 20.

On failure of the duties herein assigned they shall forfeit 8 dollars. *Ibid.* § 21.

Power of the ministers in calling special meetings of the vestry. *Ibid.* § 24.

The minister shall be one of the five of the vestry whose consent is necessary for any sale of property belonging to the church. *Ibid.* § 29.

MINISTRY.

No person ought to be compelled to frequent or maintain, or contribute, unless on contract, to maintain, any particular place of worship, or any particular ministry. Decl. 33.

MINORITY.

MISDEMEANOR.

The house of delegates may expel any member for a great misdemeanor, but not a second time for the same cause. Const. 10.

MONEY.

Foreign gold and silver coin to pass current in this state at the rates therein expressed. November, 1781, ch. 16, § 1.

To be so adjudged in all courts, and received in payment of debts, contracts, &c. except where appraisements, &c. were made in dollars at six shillings. *Ibid.*

MONEY.

All judgments, decrees and appraisements, and all penalties, fines and forfeitures, shall be rendered or made in current money, at the rate aforesaid. *Ibid.* § 2.

All former mortgages, judgments, contracts, &c. for sterling money, may be discharged in any gold or silver coin, above mentioned, at the rate of £. 166 13 4 current money for every £. 100 0 0 sterling. *Ibid.*

Ready money not to be valued or chargeable with the public assessment. 1797, ch. 89, § 1.

Monopolies are odious, contrary to the spirit of a free government and the principles of commerce, and ought not to be suffered. Decl. 39.
