The veftry, &c. of Shrewfbury parish, in Kent county, empowered to fell the glebe-land. April, 1783, ch. 14.

The glebe-land of Saint-Mary-Anne's parish, in Cacil county, directed to be fold. 1784, ch. 19.

A patent directed to issue to the vestry of Saint-Mary-Anne's parish, in Cacil county, for four acres of land therein mentioned, to be held to the use of the said parish. 1789, ch. 31.

The vestry of Christ Church parish, in Calvert county, enabled to fell the land therein mentioned, and apply the money. 1796,

The vestry of William and Mary parish, in Charles county, empowered to fell the negroes belonging thereto, and to invelt the money in real or personal property. Ibid. ch. 47.
