

SALE.

A sale of the property in the hands of an executor or administrator may be directed by the orphans courts, on application, or *ex officio*. 1798, No. 101, ch. 8, § 3, 4.

A sale may be ordered by the orphans court in case the surplus remaining in the administrators hands shall consist of specific property, or articles mentioned in the inventory, if a distribution cannot be agreed on, or the court should deem a sale more advantageous. *Ibid.* ch. 11, § 16.

The orphans court may allow a guardian to sell part of the principal of his ward's estate, but no part of the real estate shall be diminished without the approbation of the court of chancery or general court as well as the orphans court, and the said court may at any time order the sale of the personal property, consisting of specific articles, such as slaves, &c. *Ibid.* ch. 12, § 12.

SCHOOLS.

King William's school established. 1696, ch. 17, § 2.

— The rectors, &c. empowered to sell land in Dorchester county, and houses, &c. in Annapolis, towards the payment of masters, &c. 1750, ch. 26.

One school to be erected in each county, and visitors appointed, &c. 1723, ch. 19.

— Visitors incorporated for the free-school in Anne-Arundel county, with the same powers as were given by the above act, &c. 1795, ch. 66.
