 and the Right Honble. Cecilius Lord Baltimore absolute Lord and Proprietary of the  
 same to Cap. Thomas Howell of the County of Baltimore in the said Province  
 of Maryland. Gvld greeting. He has his most Excellent Ma: & Charles the  
 first of blessed memory King of England Scotland France and Ireland  
 Defender of the faith &c. did by his Letters Patents under the Great Seal  
 of England bearing date the 20<sup>th</sup> day of June in the Eighth year of his  
 Majestys Reigne and in the year of Our Lord One thousand six hundred  
 thirty two graunt unto the said Lord Proprietary this Province of Mary-  
 land according to the bounds in the said Letters Patents mentioned  
 and Expressd, wherein his said Majesty of blessed memory Specifying  
 with the bounds of the said Province to Extent to the Seabord side  
 and Delaware bay to the fortieth degree of Northly latitude, and for  
 that the said Lord Proprietary hath lately Erected a County on the  
 said Seabord side at a place called the Moreholt and called by the  
 name of Worcester County which said County was Inhabited by severall  
 persons who had taken the oath of fidelity to his said Lord and for that  
 I am informed that severall Friends Subjects of the States General of the  
 United Provinces have since taken possession of the said County by force  
 of Armes to the utter Ruin of Scattall the Inhabitants of the said  
 County & Disinherizion of his said Lord of his Just Rights, I therefore  
 upon the Speciall Trust and Confidence that I have in your fidelity  
 circumspiccon courage and good conduct do hereby Constitute ordaine  
 and appoint you the said Cap. Thomas Howell Commander in Chief  
 under me of forty men to be Raised and presid by you in the  
 County of Baltimore sufficiently provided with Armes and Ammunition  
 and them to traine Muster & Exercise in the Cittie of Baltimore, and  
 from the said County of Baltimore to leade them away unto the  
 said County of Worcester and thereby force or otherwise to surprize  
 and take and possess the said place called the Moreholt and the  
 said County of Worcester and the same to keep and defend for the  
 use of the said Seabord Proprietary and in case of any Resistance by  
 any Enemy or Enemys the said Enemy or Enemys to fight with  
 Overcome kill Destroy and vanquish as occasion shall require  
 And I doe hereby Empower you to pess such men not exceeding  
 the number of forty in the said County of Baltimore as you shall  
 Judge fit for such a designe and also to pess & take at such armes  
 and Ammunition Provision & houses necessary for the accommodation  
 of your self Officers & Soldiers and in case of any Rebellion Tumult,  
 or sedition of any of yo: Soldiers then I doe hereby Command you  
 to fight agt them according to Martiall Law and I do also hereby  
 Empower you to make and Constitute such and so many of your  
 military order you for commanding the said party as to you shall  
 seeme meet and if it shal so happen as I doe not in the least  
 doubt that you shall win the said place by assault surprize  
 or otherwise thred speed with such Enemy or Enemys that shall  
 (Resist)
