of your oyle made to vs in his Regalfe, that you make & exhibite to his Secretary of Ge Pro-
vince for the time being a true & certe and faytfull subditory of all ge aforesaid goodes
and debte; ~~whiche~~ ~~are~~ ~~to~~ ~~be~~ ~~had~~ ~~and~~ ~~held~~ ~~by~~ ~~the~~ ~~same~~ ~~person~~, and that you pay all ye debte of ge aforesaid
myselfe Scott w^t w^t owing by him selfe in his Province at the time of his deate, according
to Ge ordene of ge lawes in his Regalfe, and that you remane a true and faytfull assaynt
of ye aduera given to vs or his Secretary, before vs, & all ge persons called, and that
you labors and all & offyngs & ministris safe and garnished agst. vsours bbe, by wa^tch

do ge you, autyspe, capitale, and appoynt you and obey me of you by himselfe, to be con-
trollor of ge yowfere wilyn ge said land, to vs & expoynt all ge said goodes and autyspe
whatsoeuer wilyn ge said land, at a Justice of peace in England may be ought to vs by
w^t court of ge Commission for ge year. And furthor we do autyspe you yowde or any two of
you (w^tyspe ge said Robt. Peilott to be alwaist one) to rate and hold a Court leet at
vs & ge said land; and in ge said Court to award process, hold ghet, and to geare
and f^t determine all cause and contie w^t aliother cibill enggyn betwene any ge in-
habitants of ge said land, not exceding in Damages or Demands twelue hundred pound weight of
tobacc, and in cause w^t cibill exceeding twelue hundred weight of tobacco, we do autyspe
you ge said Robt. Peilott to have any warrant, or warrant for ge accompting of any person
or persons wilyn ge said land as ge partie of any partie; or to attac any goodes, indeft, debte, or
goods to ge people in sape m^t w^t while ge deft. shall yall in suffisent, bouncty to make
answere to ge yall at ge Court of St. maries wilyn a certaine time to be by you limittet,
and to abide ge iudgement of ge said Court. And we do furthor autyspe you yowde or any
two of you (w^tyspe ge said Robt. Peilott to be alwaist one) to enquire of, geare, de-
cument, and correct all infirmaciones & offend w^t other criminales committed wilyn ge
said land, w^t may be determined and corrected by any Justices of peace in England
& not exceeding to ge losse of life or member. And furthor to do all oþer thing
w^t shall necessary for ge exercisition of ge power & iustificacio- ghetly committed
