Cornwall, or his assigns, full & absolute power to demand & receive the same, to be or by his own power, or by the power of his assigns, and upon the receipt to give, for acquittance as shall be voidfull, wth shall be valid agt. him, or any of his assigns, from, or under him, without any further day & years above written.
