

It shall lawfull to yo^r Lieutenant Governour or yo^r Captain or Captains
yo^r authority, to make an expedition agst yo^r Indians, or yo^r Indians ...
committed to yo^r late outrage upon yo^r English, at such times, & in such manner ...
or yo^r full right sett: and to take out of every County or hundred, within yo^r ...
yo^r said man able to bear arms, two of yo^r or yo^r full right sett, to yo^r ...
said expedition. (except yo^r Lieutenant Governour and yo^r appointed, are not ...
excepted in any hundred to any purpose of yo^r act.)

Every of yo^r said man so liable upon every hundred, shall (at yo^r charge of yo^r ...
hundred) furnished & provided with one fixed gunne, two pound of powder, eight pound of ...
pistol or bull butt shot, one sword, and two month provision of victuals, and shall be ...
wounded to & from yo^r expedition with necessary & all necessary at yo^r like charge of ...
yo^r hundred.

And if any further supply of victuals be needfull to be raised aforesaid, during ...
yo^r expedition, yo^r Comandour may raise it as yo^r full be need, & put the charge it upon ...
hundred defensible, yo^r full charge it upon yo^r freemen of yo^r hundred in yo^r same ...
manner & after yo^r same proportion as yo^r charge was assessed & contributed to by ...
yo^r hundred.

And yo^r freemen of every County or hundred shall assemble at certain ...
times & places after yo^r end of yo^r assembly to be before appointed in every hundred by ...
yo^r Lieutenant Governour. And yo^r persons yo^r and yo^r assembled (or yo^r major part ...
of yo^r) shall have power to assess upon all inhabitants of yo^r hundred, what ...
& proportion of men, victuals, arms, ammunition, provisions, tobacco or other ...
articles to yo^r service, every inhabitant of yo^r hundred shall contribute or bear towards ...
yo^r funding of yo^r service, & other necessary liable upon yo^r hundred. And if ...
any so assessed shall refuse to contribute or bear yo^r thing or summe assessed upon ...
or yo^r, it shall be levied upon yo^r refuser by distress & sale of any yo^r or yo^r goods ...
or chattels.

And every yo^r person shall be liable for all yo^r person's journey or abiding with ...
yo^r or yo^r family. And if yo^r person be founden yo^r yo^r person charged in yo^r ...
county, may put it to yo^r amount of yo^r freeman, & recover it by action of debt.
And if yo^r person be apprenticed or bound to some yo^r person, yo^r ...
yo^r person so charged in yo^r county, may put it to yo^r amount of yo^r Master or dame ...
yo^r yo^r person's apprentice. And where it is uncertain to what family or hundred ...
any one doth belong, yo^r shall be charged to yo^r family, wherein yo^r had yo^r last abiding ...
at or afore yo^r time of yo^r assessment.

Provided that where any parties are aggrieved with any assessment made by virtue ...
of yo^r act, yo^r Lieutenant Governour and Council, if it be in yo^r County of ...
and yo^r Comandour & Commissioners of Court if it be in yo^r County, shall have power to ...
revise yo^r assessment, according to equity & yo^r true intent of yo^r act.

And if any thing be remaining in yo^r after yo^r expedition finished, it shall ...
returned to yo^r County or hundred from yo^r hundred to every hundred ...
from yo^r hundred to particular persons, proportionably to yo^r share

And all yo^r profits and benefits arising, growing, or accruing ...
procured by yo^r expedition, by any treaty, present, or composition ...
action for injury done, shall be yo^r & amount of yo^r persons ...
mand in yo^r provincial (Court) of any freeman (in yo^r ...
view) of any party or parties possessed of such ...
or parties so possessed shall be liable to ...
