under the same & great Seales, all writts and process, all Commissions asw^{ch}
for authorizing such persons and persons to be of & Council as we shall from time
to time appoint by warrant or direction under our hand & Seales, as for the
of justice, and for dividing & bounding of Land, all pardons, circumscribed and all other
liquid acts & deeds, w^{ch} shall at any time pass w^{ch} in & said Province

And we do further hereby grant full power & authority unto you & said
Lieutenant for us & in our name to make & grant under & said great Seales to
such persons & persons, such proportions & quantities of Land w^{ch} in & said Province
for such parts & interest and w^{ch} such privileges & immunities as were
such persons & persons day of October 1640. or from time to time shall give you
of said Lieutenant warrant for under our hand and Seales. All w^{ch} grants to be
made or passed after the same. And we do hereby declare, that all such
Seales for the passing of such Seales shall be made by our Secretary of & said Province,
for the time being, & not aforesaid: we do hereby declare, that all such
w^{ch} shall bind us & our heirs as firmly as if Liberty & Justice had been given and
granted to you.

And because we hold it fitt that ye should be sworn of & Council

And we do hereby further grant full power & authority unto you & said
Lieutenant to inquire & determine and finally to judge of & upon all causes
minimall whatsoever of what nature kind quality degree or condition soever the same
shall be, w^{ch} may happen or arise w^{ch} in & said Province of Maryland as fully and
bluntly as we or our selfe might do by force or virtue of the Statutes, Patents aforesaid
if we were actually present to give sentence or judgment of in or upon the same
(excepting only w^{ch} the life or members of any person shall or may be in question
or determined) And to award execution upon every such sentence or judgment
also to inquire & determine all civil causes, actions, suits & demands, both in Law & equity
of or concerning any goods, chattels, debts, demands, or other personal or
action or actions, suit or suits whatsoever (excepting w^{ch} are of & said Province
or your shall come in question) in the most summary & equal way that ye may
according to the orders, Lawes & Statutes of the & said Province of Maryland
made & established or to be made or established, and in default of such
Laws & Statutes, or to be established w^{ch} in & said Province of Maryland, you according
to the Lawes & Statutes of the Kingdom of England as well as ye may or may
or determine.
