¶ And we do further hereby grant full power & authority unto our selfe
in our name to make by grant under our great Seal, to pay unto or to give to us
proportion & quantities of land within this shire: for payement & delivery, the
same privileged & immunitie, as we shall or from time to time shall give in
our warrant for under our great & sealed: all our grants of lands made
as well as granted after these same grants. Also said warrant under our great &
sealed: for passing thereof shall be directed by our Secretary of State: for the
time being; and after yeal of our Secorday shall be delivered under our great & sealed
warrant & backside of every such grant, that ye said grant & warrant under our
great & sealed: for passing thereof are intended, that ye grants or grants
shall be made by conditions of grants; (if ye grants be passed by written copy)
concerning arms & ammunition, or given caution for the performance whereof
out of your selfe defining, & also taken by oal of fidelity to your Lord Propriet
& also after yeal of our Secorday. Generall copy for the time being or yeal day
shall be likewise delivered under our great & sealed: for backside of every such grant
yeal of ye land wherein mentioned. Also to seeke whereby purveyed & provided, no more in
quantity than it ought to doe by warrant from us; we do hereby declare & give
affirmation in law & not before us, to & shall bind us to doe as firmly as
if libens & biscaies had beene given & appointed aforesay.

And we doe will & require v^e g^d. It is advise as Generallie may be w^e y^e
m^e p^e alie from time to time notated up^e Comitt^e upon all occasions concerning
ye good gobernment. of d^e g^r. g^v. of M^e. N^e p^e y^e y^e y^e.

And we do further give & grant full power & authority unto S. & J. to inquire

or arise within S. & J. &c. of M. according to law & usage of S. & J. or in default thereof
according to best best information, as fully & absolutely as we & J. might do by
ourselves without application thereto, so far as if we were specially sent to y^e place, & had
no indirec^t of in or upon the same (nothing only where as to life or members of any
of them shall or may be imputed or discerned.) And to award reparation upon
every such judgment or indirec^t. And also to govern & determine all civil &
actions suits & demands b'z in law & equity of or concerning any goods chattels
