

of the said Great Seal do cause a Grant to be paped under his ~~own~~ Great Seal of the said Province to the said Edward Eltonhead as his ~~own~~ the said Proportion of Land according to the true intent & meaning of the said Warrant & Declarations as aforesaid and in case he find a Patent or Grant paped herebefore under his ~~own~~ said former Great Seal there to the said Edward Eltonhead according to the true intent & meaning of the said Warrant & Declarations but that the original Patent or Grant is lost & cannot be found to be sent to the said Edward Eltonhead, then his ~~own~~ Authorizes & requirys his ~~own~~ Lieut. & Keeper of his Great Seal to cause an Exemplification to be forthwith made & paped under his said Lordships Next Great Seal of the said Grant or Patent upon Record there & to send the said Exemplification by the first opportunity to his ~~own~~ the said Edward Eltonhead.

4. That his Lordship doth hereby authorize his said Lieut. of the said Province with the advice & approbation of his ~~own~~ said Bygger to readmitt if he thinke fitt ~~the~~ Robert Clarke to be. One of his ~~own~~ Tops Council of the said Province to all intents & purposes what soever in as full & ample manner as formerly he was by his ~~own~~ Commission for that purpose to him and also to add any other Person or persons inhabiting the said Province not exceeding the number of six to be of his ~~own~~ Tops Council there to all intents & purposes overes above such as are already or that shall hereafter be nominated & appointed by his ~~own~~ to be of his ~~own~~ Council there provided that such person or persons so to be added to his ~~own~~ Council there as aforesaid do take the oath of a Councillor there to his ~~own~~ before he, or they do Act as one of his Lordships Council there respectively.

5. That his Lordship doth hereby authorize his Lieut. of the said Province for the time being with the Approbation of any three of his ~~own~~ of his Lordships Council there whereof his ~~own~~ Tops Principall Secretary for the time being to be always present to make any Foreigner as he shall thinke fitt capable of his ~~own~~ Tops Conditions of Plantacon there & to cause Grants or Patents of Land there to be paped unto any such person or Persons accordingly as if he she or they were of British or Irish descent any former Commission Warrant or Direction from his ~~own~~ to the contrary in any wise notwithstanding.

Whereas his ~~own~~ hath in these Instructions & otherwise Authorized & appointed his Lieut. of the said Province for the time being & in particular the aforesaid Captaine Josias Fendall his Lordships present Lieut. there to Act & do severall things with the advice & approbation of his ~~own~~ Tops Brother Philip Salvert Esq. Nowe in case the said Philip Salvert should dye or by absence out of the said Province or otherwise should be disappointed of Acting there according to his ~~own~~ doth hereby authorize & appoint in every such case the said Captaine Josias Fendall & every other his ~~own~~ Lieut. of the said Province for the time being to Act & Doe the same
