

For the quiddit Rule and Governor of the people in all and every
 the Articles of the same And to chastise and punish all persons
 offending agt the forme of any of the lawes and orders of this our
 Province or of any of them in St. Marge County aforesaid and according
 to the forme of the lawes and orders shall befall to be done And have
 also constituted and ordeined yo^r and every four or more of yo^r of which
 yo^r the said William Evans John Abington Thomas Mathew or
 Thomas Dent, unto some one of our Councill to be present and allwayes to
 be and for to be enquired by the oathe of good and lawfull men of yo^r County
 aforesaid of all manner of transgressions withcrafts and heresies. Dore
 ego Magist^r Arth^r waspasse fordistallings nigrosingis and Exorsours
 whatsoever And of all and singuler of her misdoings and offences of
 whiche Justice of the peace in England may or ought lawfully to be
 quired by whomsoever or whosoever done or perpetrated or being
 hereafter shall happen to be done or perpetrated in the County aforesaid
 agt the lawes and orders of this our Province Provided yo^r provide
 not in any of the cases aforesaid to take life or member, but that in every
 such case yo^r send the Prisoners with their Auditm^t and be whole
 matter depending before yo^r to the next Court for to be hearden for
 this our Province whosoever or whosoever to be hearden there to be
 tried And further we do hereby authorize yo^r to issue writte pro-
 cess arrests and Attachm^t to hold ye for of hearers and determine
 and after Judgmt^t execution to be made in all causes civil and her in
 attone, real or personall, where the thing in action doth not exceed the
 value of three thousand pounds of tobacco according to the lawes orders
 and reasonable customes made and used in this our Province of Vir-
 gylia and in whiche causes civil so to be tried And do constitute
 Ordain and appoynte yo^r William Evans John Abington Thomas
 Mathew or Thomas Dent to be Judges as aforesaid and also some one of
 our Councill to be then in Court And therefore we command yo^r that
 yo^r diligently pursue the keeping of the said lawes and orders
 and all and singuler of the said penalties and at certain dayes and places
 whiche yo^r or any four or more of yo^r as aforesaid shall in that behalf
 appoynte yo^r make Enquiries upon the said penalties And performe and
 fulfill the same in forme aforesaid doing therein that which is just
 appoynted according to the said orders and reasonable customes
 of this our Province having to us the Sherriff and other heres
 thereof to be belonging And therefore we command the Sherriff of
 the said County of St. Marge by vertue of this present Let at certain
 dayes and places whiche yo^r or any four or more of yo^r as aforesaid
 shall make known to him to give the Attendance on yo^r And if need require
 to cause to come before yo^r or any four or more of yo^r as aforesaid
 such and so many good and lawfull men of yo^r County by whom they
 truly in the said penalties may the better be knowne and Enquired of And
 Lastly we have appoynted Walter Jagg & sons and Executors of the
