

Assembly you do likewise summon and call all our privy Councello to sit in the upper house of Burgoyne together with, and, should not exceeding the number of seven members of our said Province, the said should so to be called and summoned to be Lords of Mans. If you shall find any such to be fitting to sit in the upper house of Assembly together with our said privy Councello as in your Discretion you shall think fit. Herein the said the without to be by you at any time summoned are not to sit in the said house before they shall have taken the oath of fidelity to be administered by the Chancellor or any two of our Councello by your appointment.

Item that to all such bills laws or Acts as you shall hereafter receive from us under our Seal to be offered and proposed to any Assembly of our said Province hereafter to be called or summoned you do at all times give our publick assent and give the same to be published under our said Seal of our said Province in case such Assembly shall assent unto and approve of the same.

Item that from henceforth you forbear to sit in either house of any Assembly as a member of the same but that so often as you sit in the upper house of any such Assembly you shall take place as our first person and at representing us in our absence.

Item as touching such Acts as any late Assembly have passed or framed contrary to Justice Right Equity or Reason, the particulars of which you shall receive here with under our Seal and Seal you do publickly before and in the presence of both the houses of the said Assembly to be by you called and summoned declare our Dissassent and disagreement to the same and leave it to our said Secretary to give the Reason of such our dissassent and disagreement we leaving fully impartial the same unto him.

Item that in case you shall happen to find your self sick or in danger at any time of death you take care by your last will or other Instrument to appoint some fitting person or persons of our privy Councello to succeed you in the office and Office of Governour of and in our said Province, untill we shall appoint and authorize some other person to exercise and execute the said Office, And we do hereby allow of authorize and appoint such person or persons as you shall so appoint as aforesaid to exercise and execute all and every the said Office and Offices powers and authority whatsoever after your death, untill we shall nominate and appoint some other person or persons to exercise and execute the same.

Item we do hereby authorize you so often as you shall find occasion from time to time and at all times hereafter to suspend any person or persons our said Chancellor Secretary only Excepted from sitting or being of our privy Councello in our said Province or from exercising or executing any Office or Office Military or Civil within our said Province during your pleasure and untill our pleasure to the contrary be by us signified and we do hereby expressly prohibit declare and Enjoin that every person and persons (except before Excepted) so by you suspended, or to be suspended shall be and are hereby suspended from the exercise and execution of such Office and Office from the exercise and execution whereof he shall be suspended and is and are hereby prohibited and enjoined from the exercise and execution of the same, untill we or you shall declare our Express will and pleasure to the contrary.

Item we do hereby give you full power and authority for us and in our name in case of the death of any Officer or Officer of our said Province or of any of our privy Councello or privy Councello, or in case of any such suspension as aforesaid, to appoint some other fitting person or persons to exercise the Office or Office of such person or persons so appointed or to be suspended as aforesaid untill we or your will shall be declared to the contrary.
