writing, we do hereby will require you and authorise you our said Lieutenant and
you our said Council of our said Province of Maryland from time to time to observe and form
and execute our welfare and protection of these Instructions and authority so
hereafter mentioned in such manner and for no other cause are hereby ordered and directed
to be observed perused and executed (that it so say)

Iustice will and require you and every of you that you do most strictly and carefully
observe and execute and cause to be observed kept and executed one certaine Act of
Assembly made in the nineteenth year of our Dominion Entituled an Act concerning
Petition, and every clause Article and Section therin contained.

Iustice will and require you in your respective places and according to your
Respective powers take care to prevent the selling and puttynge off all and all
manner of Riot and sedition and rebellion, Riotous sedition and rebellion affreighted
and meetings within our said Province and Dominion, tendyng to the disturbance of our
peace and government, or of the quiet of our said Province.

Iustice will and require you in your respective places and according to your
Respective powers take care to prevent the sale or delivery of any manner of gun
nuckles carbines pistolls shooting pieces, swords cutapont, gun powder shot
Bullets or other munition whatsoever to any manner of Indian or Indians
whatsoever, and strictly and severly to put in execution our cause to be put in
Execution all manner laws rules and Ordinances for prevention of the same.

Iustice will and require you take into your strict and severall consideration all laws and rules
already made, and to which we have given our effect bengay and Relating in any
respect to any trading dealing traffique or trucking with any manner of Indian
whatsoever, and strictly and severly to observe and execute the same and to cause and
procure the same to be strictly and severly observed and executed and also carefully
Diligently to observe and examine wher and in what place and the said lawes or
any of them are defective, and to certify us your opinions and judgment in relation
to the same with your opinions how the same may be amended altered and corrected

Iustice will and require you in your respective places and according to your
Respective powers do execute and enreke and cause to be done perused and executed
freely and equall justice and right to all manner of persons and particularly to all
