Surveyor, our Lieut: & other Officers of State Government or Justice respectively, wherefore we  
do hereby authorise and appoint you our said Lieutenant General to give and  
Administer such oaths and oaths unto our said Deans Brothers and all by our orders  
and command to be Administered unto and taken by our Surveyor of our said  
Province, and unto such as are to sit and be of our said Privy Council, and otherwise  
such oath as we have Directed to be Administered to our Judges Justices or Commissioners  
of our said Provincial Court and unto them respectively authoris<sup>d</sup> our said Deans  
Brothers after he shall have been so sworn ab aforesaid and shall have taken  
the said oaths and respective oaths hereby appointed to be Administered unto  
him ab aforesaid to give and Administer unto our said Deans Brothers such oaths and  
oaths ab it and all by our order and command to be Administered unto and taken  
by our Lieutenant General them. And also such as by like order and command  
are now by us Directed to be and taken by such as by our Authority are  
appointed and authorized to sit and be Judges Justices or Commissioners of our said  
Provincial Court. And also to give and Administer unto our said Principal  
Secretary such oath ab by our order and command to be Administered unto or  
taken by our Principal Secretary of our said Province, and also to give and  
Administer unto our said Principal Secretary and all others ordained Constituted  
or appointed by us to be of our Privy Council or of the Privy Council to  
Lieutenant General and to sit and be Judges and Justices of our said Court such  
oathes and respective oaths and oaths ab by our appointment and command to be  
Administered unto and taken by such as we have appointed and  
authorized to sit and be Judges Justices or Commissioners of our said Provincial Court.

Ihere that you seriously take into your consideration to find and speedily to  
propose unto us some convenient way of and for the making of some visible  
Distinction and Distinguishable between you our Lieutenant General our  
Principal Secretary, General Officers, Councilors, Judges, Justices and  
the rest of the people of our said Province either by the wearing of habdles  
Middle or otherwise.

Ihere we do further Direct and appoint by these presents that if at  
any time in our absence from our said Province our Lieutenant General of  
our said Province for the time being shall happen to dy without having  
power from us to appoint some person or persons to succeed him in the Exercise  
of Execution of the said Office and the powers thereto belonging or without  
appointing some person or persons to succeed him ab aforesaid that in all and  
Every such case and cases happening it shall and may be lawfull and comande  
herty authorise and give power unto our Privy Council of our said Province  
for the time being to elect and appoint some person or persons of our Council  
for the time being, and residing in our Province to Exercise and Execute the  
Office of Lt: General and Chief Garrison of our said Province until we are  
or our heirs or assignees and proprietaries Lords or Proprietaries of the  
said
