

said Province shall constitute a Lieutenant Governall and Chief Governour of the said Province to succeed the person so happening to dy at aforesaid, And we do hereby authorize full power unto you or persons to be appointed by our said Council to execute and execute the said Office according to full appointment of our said Council taking all oaths by us appointed to be taken by our Lieutenant Governall and Chief Governour of our said Province.

Item that the Method to be used for the future and at all times hereafter for the swearing and Administering of all full oaths at any or shall be by us hereafter appointed to be Administered unto and taken by our Governall Chancellor, Principall Secretary privy Councill or privy Councill Judges or Justices of our said Provincial Court shall in this manner (that is to say) that our Lieutenant Governall for the time being or in his absence his Deputy or Deputies to be by him appointed shall by virtue of this power and of his and their Office administer unto full power or persons at shall hereafter at any time by us or our authority be chosen or appointed to be our Chancellor of our said Province the full oaths appointed by us to be taken by and Administered unto our Chancellor of our said Province one of our said Privy Councill, and to the Judges and Justices of our said Provincial Court respectively, and that our Chancellor of our said Province for the time being or in his absence, or in case there be no Chancellor then one of our Privy Councill of our said Province, to be appointed by our privy Council of our said Province shall Administer unto full power or persons at shall at any time hereafter by us or our authority be chosen or appointed to be our Lieutenant Governall of our said Province, and ^{unto} full power or persons at shall any full Lieutenant Governall be appointed to be Deputy Lieutenant of our said Province full oaths and oaths at it or any by us appointed to be Administered unto and taken by the Lieutenant Governall of our said Province in case the person appointed to be sworn be appointed to be our Lieutenant Governall of our said Province. and in case full power to be sworn be only appointed to be Deputy Lieutenant of our said Province, then full oaths and oaths at it or any by us appointed to be Administered unto and taken by the Deputy Lieutenant of our said Province, at also unto the same person or persons to be chosen or appointed to be our Lieutenant Governall or to be Deputy Lieutenant at aforesaid full oaths and oaths at it or any appointed to be Administered unto and taken by the Judges and Justices of our said Provincial Court and that our Chancellor of our said Province for the time being or in his absence, or in case there shall be no Chancellor then one of our Privy Councill of our said Province to be appointed by our Lieutenant Governall of our said Province or by his Deputy or Deputies shall Administer unto every such person and persons respectively at shall by us or by our authority be at any time hereafter chosen or appointed to be of our privy Councill of our said Province full oaths and oaths at it or any by us appointed to be taken by full power at any or shall be constituted at aforesaid to be of our privy Councill of
