

On the backside of the foregoing Instructions was thus written (vizt) Memorandum that on the 17<sup>th</sup> day of May A.° 1666. the within named Philip Calvert Esq took the within written oath of Chancelour of the said Province, the oath of a privy Councello, and the oath of a Justice of the Provinciall Court, the said severall oaths being then tendered unto him at St. Johns within the said Province by the within named Charles Calvert Esq Lieutenant Governour, and Chief Governour of the said Province, in the presence of Richard Boughton, and Jerome White Esqs. Memorandum that the day and year above written the within named Charles Calvert Esq took the within written oath of Lieutenant Governour and Chief Governour of the said Province the oath of a privy Councello, and the oath of Chief Justice of the Provinciall Court, the said severall oaths being tendered to him at St. Johns above said by the within named Philip Calvert Esq Chancelour of the said Province in the presence of Richard Boughton and Jerome White Esqs.

Memorandum that the day and year above written the within named Richard Boughton Esq and the above named Jerome White Esq took the severall and respective oaths following (vizt) the said Richard Boughton the within written oath of the principall Secretary of the said Province, and the said Richard Boughton and Jerome White the oaths of a privy Councello and Justice of the Provinciall Court the said severall oaths being tendered to them respectively by the said Lieutenant Governour and Chancelour at St. Johns above said.

Memorandum that the nineteenth day of May in the year above written William Coomb Esq and Henry Curfey Esq did severally take the said oaths of a privy Councello and Justice of the Provinciall Court the said oaths being tendered unto them by the said Lieutenant Governour and Chancelour at St. Johns above said.

Memorandum that the twentieth day of June in the year above written Peter Brooke and Thomas Truman Esqs did severally take the said oaths of a privy Councello and Justice of the Provinciall Court the said oaths being tendered unto them by the said Lieutenant Governour and Chancelour.
