By his Excellency the Gov: and Chief Governour of y<sup>e</sup> said Province

Whereas it hath been informed that till or no Corn or Provision is  
 liberty to be raised or made this present year within this Province  
 and that some all persons make it their business to purchase and  
 purchase Corn and Provision to export out of this Province  
 which may probably happen to the detriment and great  
 damage to the Inhabitants of this Province: Be it hereby  
 Enacted & proclaimed published & declared that no person or  
 persons whatsoever do export or cause to be exported out  
 of this Province any Corn, Cattle, Horses or other provision  
 whatsoever without the special leave or License of the  
 Gov: & Council of this Province first had and obtained as  
 they will answer the Court at their peril and that the  
 Sheriffs of the respective Counties make Proclamation hereof  
 Given under my hand and y<sup>e</sup> lesser Seale of this Province  
 the 13<sup>th</sup> day of October in the 43<sup>th</sup> year of the Dominion of  
 Charles & Anne Queen 1674

Cecilus absolute Lord & Proprietary of the Province of Maryland and  
 Avalon Lord Baron of Baltimore &c Doall shew to whom these presents  
 shall come greeting in God Everlasting Whereas Messrs. Stykelkan  
 comes in the Netherlands under the Dominion of the States of the  
 seven Provinces & a subject of the Nation aforesaid having  
 transported himselfe into this Province here to Inhabit hath  
 besought us to graunt him the said Messrs. Stykelkan leave here  
 to Inhabit & as a free Denizen freedome land to him & his heires  
 to purchase Know ye that we willing to give due Encouragement  
 to the Subjects of that Baron doe hereby declare him the said  
 Messrs. Stykelkan to be a free Denizen of this our Province of  
 Maryland And doe further shew us our heires & Successors  
 straitly Enjoine constitute Ordaine & Command that the said  
 Messrs. Stykelkan in all things be held treated reputed & esteemed  
 as one of the faithfull people of us our heires & Successors borne  
 within this our said Province of Maryland And likewise & lands  
 tenements Revenues services & other hereditaments whatsoever  
 within our said Province of Maryland may Inherit or otherwise  
 purchase receive take have hold buy & possess And that he  
 may buy & enjoy Give Sell Alien & bequeath As likewise all  
 Liberties Privileges & Inpriviledges of this our Province of  
 Maryland Surely quietly & peaceably have & possess buy &  
 enjoy as our faithfull people borne or to be borne within our  
 said Province of Maryland without the least molestation Repulse  
 or grievance of us our heires & Successors Any Lawe to the  
 contrary hereof notwithstanding Given at the City  
 of St. Maryes under our great Seale of our said Province of  
 Maryland this Eighth day of May in the 43<sup>th</sup> year of our  
 Dominion over our said Province Anno Domini 1675. Wmms
