Commission^s to Enquire by the Oath^s of good & lawfull men of yo^r County —
aforesaid of all manner of felonies Wilkerastes Inchantment Sorcery & Magie
Arts Trespasses Forstallings^r Ingrossings^r Extortion whatesoev^r kind of all
singular other misdeeds & Offences of which Justice of the Peace in England
may or ought lawfully to Enquire by whomsoever on whosoev^r daud or
perpetrated or whch hereafter shall happen to be done or perpetuated in the
County aforesaid against the Lawes & Ord^rs of our said Province provided
you to recd not many of the rases aforesaid to take life or member But that
in every such Case you send the Prisoner^s with the Indictm^t & the whole
matter depending before you to the next Provinciall Court to be holden
for our said Province whosoev^r or whet so ever to be holden there to be
tryed And further we doe hereby Authorize & to Issue writs Process & Chrg^r
& Attainm^t to hold Pleas of Assize & Ternimer after Judgmen^t Execution to
Award in all causes civil whther in Actions Real or Personal where
the thing in Action doth not Exceed the Value of thuse Thousand pounds
of Tobacco according to the Lawes Orders & reasonable custome made
use in our said Province of Maryland In which cause^s to be tryed
we doe constitute Ordyned & Appoint you Tho: Dent, John Jordanne, W^m
Boardman & Gerard Slye to be Judge as aforesaid unless some one of
