

grant unto Our Said Dear Sonne, full power and authority -
 During the time of his having holding and enjoying the Said
 Office before mentioned by his Deputy and Officers by Us to be
 appointed to levy muster and drayne all Sorts of Men of what
 condition, or wheresoever borne in Our Said Province & Dominions
 for the time being remaining. And in case of Insurrection
 assault or approaching of any Enemy or Enemies private or
 private or other Robbers to make War, and to pursue such
 Enemy or Enemies private or Robbers aswell by Sea as Land and
 to vanquish and take them, and being so taken to putt them to
 death by the Law of War, or to spare them at his pleasure.
 And by his Deputy by Us to be appointed to doe all & every
 thing which unto the Charge and Office of a Captaine Generall
 of an Army or Admirall of a fleet belongeth. And likewise in
 case of any Rebellion Tumult or Sedition, either upon the Land within
 Our Said Province and Dominions or upon the Sea to exercise
 Martiall Lawes against all rebellious Mutinours or Seditious persons
 who shall refuse to Submit themselves to Our Government or to
 serve in the Wars, or shall fly to the Enemy or forsake their
 Ensignes or be souldiers or straglers or otherwise howsoever offending
 against the Law Custome or Discipline Military w^{ch} freely and in
 w^{ch} ample manner and forme w^{ch} any Captaine Generall of an
 Army or Admirall of a Navy by virtue of his Office might or
 hath accustomed to use the same. And further Wee doe give
 and grant unto Our Said Dear Sonne full power and authority.
 During the time of his exercise of the Said Office by his Deputy
 by Us to be appointed w^{ch} aforesaid for Us and in Our name and
 w^{ch} often w^{ch} his Said Deputy shall thinke fitting from time to
 time to pardon remit ^{or} release, whether before judgment or after all
 all manner of Criminall Offences against the Lawes of Our Said
 Province and Dominions or any of them and w^{ch} all and all manner
 of fined penalties & forfeitures incurred or to be incurred by any
 person or persons Bodies politique or Incorporate within Our Said
 Province and Dominions or any of them for or by reason of any
 Crime or Crimes Offence or Offences committed or to be committed
 against any of the Lawes Ordinances or Orders of Our Said
 Province heretofore made or hereafter to be made whatsoever
 or howsoever w^{ch} fully and amply to all intents constructions
 and purposes w^{ch} Wee Our selfe may doe being personally present
 in Our Said Province. And also for Us and in Our name
 and w^{ch} often w^{ch} his Said Deputy shall find it necessary from
 time to time to call Assemble and Summon any Generall Assembly
 or Generall Assemblies of the freemen of Our Said Province
 or of their Deputyes or Delegates for the giving of the
 advice assent and approbation of the freemen of Our Said
 Province to such Lawes and Actes as shall be by Us at any
 time Ordained made and enacted and under Our Seale published
