

and unto which the advice assent and approbation, of the freemen  
of Our said Province shall be at any time requisite necessary  
and the Said General Assembly and Assemblyes so from time to  
time called Assembled and Summoned, or to be called assembled or  
Summoned - from time to time when and as often as His Said Deputy  
shall judge it necessary in Our name to prorogue or otherwise to do  
dissolve at His Said Deputyes pleasure. And likewise for Us and  
in Our name and in Our absence - from Our Said Province to ordaine  
make and enact by and with the advice assent and approbation -  
of any such Assembly or assemblyes so called assembled or summoned  
as aforesaid to be of force until We Our selfe or Our Heirs  
or assigns Lord and Proprietary Lords and Proprietaryes of the  
Said Province shall declare and publish or cause to be declared  
or published within Our Said Province his thair or some of their  
particular differt or diffeint disagreement or disagreements to  
this Lawe under Our his thair or some of their Seale or Seales  
So as this Lawes and Acts so to be Ordained made & enacted  
be conforant to reason and be not repugnant or contrary but as  
here as reasonably may be agreeable to the Lawes Statutes and  
Customes of the Kingdome of England and so as the same be no  
wayes repugnant unto or destructive of Our Rights privileged  
or jurisdictions, or to the Dominion of Us Our Heirs or assigns  
Lords and Proprietaryes of the Said Province, or contrary to Our  
or their power Government or Dominion or contradictory to a  
certaine Act of Assembly heretofore made in the nineteenth year  
of the Dominion of Our dearest Father of Noble memory Among  
One thousand six hundred and fifty intituled An Act concerning  
Religion. And likewise thereto further give and grant unto Our  
Said Deputy Sonne during the time of his office of the Said Office aforesaid  
full power and authority from time to time by His Deputy to make -  
constitute ordaine and publish in Our name such wholesome/reasonable  
and profitable Ordinances Edicts and proclamations within Our Said  
Province for the better governing of the people in Our Said Province  
and with such reasonable paines and penalties to be therein expressed  
as We Our selfe may lawfully doo being personally present in  
Our Said Province. And also full power and authority to direct and  
appoint for Us and in Our name to passe under the great Seale of  
Our Said Province such Grant and Grants of such proportion and  
proportions of Land within Our Said Province to such person or  
persons and for such estate and estates and with such privileges  
and immunitiess and under such conditions as were formerly by Our  
dearest Father directed or which We shall - from time to time  
hereafter direct by any warrant or warrants under Our Said  
Seale at Arms. So as this Said warrant and warrants be only
