 Jeffre Wharton Esq; One of Our Councill, whom by these presents  
 we constitute authorise and appoint Our Deputy Lieutenant and  
 Deputy Governor under Our Said Deare Sonne during Our  
 absence Out of Our Said Province or until We or Our Heirs  
 shall signify Our or their pleasure to the contrary. Herby  
 giving and granting unto the said Jeffre Wharton the Juste  
 Government and command of Our Said Province as Our Deputy  
 Lieutenant and Deputy Governor under Our Said Deare Sonne  
 during Our Said absence And also by these presents empowering  
 the said Jeffre Wharton as Our Deputy under Our Said Deare  
 Sonne to execute and execute all the several powers & authority's  
 aforesaid mentioned. Willing and by these presents requiring the
