 powers and authorities by these presents given and granted to Our
 said Dear Son be from time to time (as Occasion shall
 require) exercised performed and executed for Our said Dear Son
 (by reason of his tender years) by Our trusty and wellbeloved
 Jesse Wharton Esq^r One of Our Councill, whom by these presents
 We constitute authorize and appoint Our Deputy Lieutenant and
 Deputy Governour under Our said Dear Son during Our
 absence out of Our said Province or until Wee or Our heirs
 shall signify Our or their pleasures to the contrary. Hereby
 giving and granting unto the said Jesse Wharton the Custody
 Government and Command of Our said Province as Our Deputy
 Lieutenant and Deputy Governour under Our said Dear Son
 during Our said absence And also by these presents empowering
 the said Jesse Wharton as Our Deputy under Our said Dear
 Son to exercise and execute all the severall powers & authorities
 above mentioned. Willing and by these presents requiring the
 said Jesse Wharton to advise at there shall be Occasion with
 those who already are or hereafter shall be of Our Councill here
 for the time being upon all emergent Occasions touching concerning
 or relating unto the good Government of Our said Province and
 people here. Given at Mattapenny under Our hand and great Seal
 of Our said Province the sixteenth day of June in the first
 year of Our Dominion over Our said Province and in the year
 of Our Lord God One thousand Six hundred Seventy Six.
