 some months and that during his absence out of the said Province
 he had thought fitt and requisite the Chief Demand should be
 in his deare Sonne Cecil Calvert Esq (he the said Charles
 Lord Baltimore Lord Proprietary as aforesaid did by these presents
 give and grant unto his said deare Sonne Cecilius the Office of
 Lieutenant Generall Chiefe Captaine Chiefe Governour & Comander
 and cheife Admirall both by Sea and Land of the said Province
 of Maryland and of the Island Territories and Dominions
 whatsoever to the same belonging and of all and singular his
 Castles Forts Fortresses Fortifications Munitions Shippes
 and Navyes in the said Province Island Territories & Dominions
 aforesaid and from the said Cecil Calvert Esq his Lopp did Ordaine
 and constitute Lieutenant Generall Chiefe Captaine and Chiefe
 Admirall both by Sea and Land Chiefe Governour and Comander
 of the said Province Island Territories and Dominions and of
 all the Castles Forts Navyes Shippes places and things aforesaid
 by these presents to have hold Occupy enjoy and exercise the said
 Office of Lieutenant Generall Chiefe Captaine and cheife Admirall
 Chiefe Governour and cheife Comander as aforesaid with the appurtenances
 unto the said Cecil Calvert by his Deputy in his Loppes absence by
 his Lopp to be appointed. And his Lopp did likewise give and grant
 unto his said deare Sonne full power and authority during
 the time of his having holding and enjoying the said Office before
 mentioned by his Deputy and Officers by his Lopp to be appointed
 to levy mustre and trayne all sorts of men of what condition or
 wheresoever borne in the said Province and Dominions for the
 time being remaining, And in case of Insurrections Assaults or approaching
 of any Enemy or Enemies private or pirates or other Robbers to make
 Warre and to pursue such Enemy or Enemies private or Robbers by
 Sea or Land and to banquish and take them and being so taken to putt
 them to death by the Law of Warre or to save them at his pleasure.
 And by his Deputy by his Lopp to be appointed to doe all and everything
 which unto the charge and Office of a Captaine Generall of an Army or
 Admirall of a fleet belongeth And likewise in case of any rebellion
 Tumult or Sedition either upon the Land within the said Province and
 Dominions or upon the Seas to exercise Martiall Lawes against rebellious
 mutinous or Seditious persons which shall refuse to submit themselves
 to his Loppes Government or to serve in the Warre or shall fly to
 the Enemy or forsake their Ensignes or be Loyterers or Straglers
 or otherwise howsoever Offending against the Law Justice or discipline
 Military or civill and in all ample manner and forme as any Captaine
 Generall of an Army or Admirall of a Navy by virtue of his Office
 might or hath accustomed to use the same. And further his said
 Lopp did give and grant unto his said deare Sonne full power and
 authority during the time of his exercise of his said Office by his
