

Deputy by his Lopp to be appointed as aforesaid for his Lopp and in his name and as often as his said Deputy shall thinke fitting from time to time to pardon remitt or release whether before judgment or after all and all manner of Criminnall Offences against the Lawes of the said Province and Dominions or any of them, and also all and all manner of finishe penalties or forfeitures incurred or to be incurred by any person or persons Bodies politique or Corporate within the said Province and Dominions or any of them, for or by ^{reason} ~~reason~~ of any crime or crime Offence or Offences committed or to be committed against any the Lawes Ordinaunces or Orders of the said Province heretofore made or hereafter to be made whatsoever or howsoever as fully and amply to all intents constructions and purposes as his Lopp himselfe might doe being personally present in the said Province. And also for his said Lopp and in his name and as often as his said Deputy shall thinke it necessary from time to time to call assemble and Summon any Generall Assembly or General Assemblies of the freemen of the said Province or of their Deputyes or Delegates for the giving of the advice assent and approbation of the freemen of the said Province to such Lawes and acts as shall be by his Lopp at any time Ordained made and enacted and under his Lopp's Seale published and unto which the advice assent and approbation of the freemen of the said Province shall be at any time necessary and requisite, and the said Generall Assembly and Assemblies from time to time called assembled and Summoned or to be called assembled or Summoned from time to time when and as often as his said Deputy shall judge it necessary in the name of his Lopp to prorogue or otherwise to dissolve at his said Deputyes pleasure. And likewise for his said Lopp and in his name and in his absence from his Lopp's said Province to Ordaine make and Enact by and with the advice assent and approbation of any such Assembly or Assemblyes so called assembled or Summoned as aforesaid to be of force until his said Lopp or his heire or assignes Lord and Proprietary or Lords and Proprietaryes of the said Province shall declare and publish or cause to be declared or published within the said Province his ^{or some of their} particular dissent or dissent's disagreement or disagreements to the same under his or some of their Seale or Seales; So as the said Lawes and Acts so to be Ordained made and enacted be consonant to reason and not repugnant or contrary but as near as reasonably may be agreeable to the Lawes Statutes and Customes of the Kingdom of England, and so as the same be in wayes repugnant unto or destructive of his Lopp's Rights priviledges or jurisdictions or to the dishonour of his Lopp his heire or assignes Lords and Proprietaryes of the said Province or contrary to his Lopp's or their power Government or Dominion, or contrary to a certaine Act of Assembly heretofore made in the nineteenth yearre of the Dominion of Cecillius his Lopp's deceased father of Noble memory Amongst Down One thousand six
