

hundred and fifty intituled An Act concerning Religion. And his said  
 Lopp did likewise further give and grant unto his said Deare Sonne  
 during the time of his exercise of the said Office aforesaid full  
 power and authority from time to time by his Deputy to make  
 constitute and Ordaine and publish in his Lopp name such wholesome  
 reasonable and profitable Ordinances Edicts and Proclamations  
 within the said Province for the better governing the people  
 within the said Province and with such reasonable paines and  
 penalties to be therein expressed as his said Lopp himselfe might  
 lawfully doe being personally present in the said Province.  
 And also full power and authority to direct and appoint for  
 his said Lopp and in his name to passe under the great Seale of  
 the said Province such grant and grants of such proportion and  
 proportions of land within the said Province to such person or  
 persons and for such Estate and estates and with such privileges  
 and immunities and under such Conditions as were formerly by  
 his Lopp said deceased father directed, or which his Lopp  
 should from time to time hereafter direct by any warrant or warrants  
 under his hand and Seale at Armes so as the said warrant or warrants  
 be duly entered and registered and the said lands duly surveyed  
 and the Surveys thereof returned and all and every the necessary  
 ruled Orders circumstances heretofore by his Lopp said deceased  
 father given or appointed in relation to the surveying of such  
 lands and to the entering registering and attesting the Surveys  
 thereof, and all necessary circumstances touching such grants surveys  
 and warrants heretofore by his Lopp said deceased father given  
 and appointed be first duly observed and performed. Willing and  
 thereby requiring that all the abovesaid powers and authorities  
 by those presents given and granted to his Lopp said Deare Sonne  
 should be from time to time (as Occasion should require) exercised  
 performed and executed for his Lopp said Deare Sonne (by reason  
 of his tender years) by me the said Jesse Wharton whom by those  
 presents his Lopp did constitute authorize and appoint his Deputy  
 Lieutenant and Deputy Governour under his said Deare Sonne during  
 his Lopp absence out of the said Province or until his Lopp or  
 his Lopp should signify his or their pleasure by the contrary.  
 And also giving and granting unto me the said Jesse Wharton  
 the Juste Government and Command of his Lopp said Province  
 as his Lopp Deputy Lieutenant and Deputy Governour under  
 his said Deare Sonne during his Lopp said absence. And also  
 by those presents empowering me the said Jesse Wharton as his  
 Deputy under his said Deare Sonne to exercise and execute all the  
 severall powers and authorities abovesaid Willing and by those  
 presents requiring me the said Jesse Wharton to advise as there  
 shall be Occasion with those who already are or hereafter shall be  
 of his Lopp Council here for the time being upon all Emergent  
 Occasions touching concerning or relating unto the good Government.
