

- Instructions Directions and authorities hereafter mentioned in such
 manner and forme as the same were thereby Ordained & directed
 - to be observed performed and executed that is to say first That
 in case it should happen I should find my selfe sick or in danger
 at any time of death that I should take care by my last Will
 or other instrument to appoint his Loppes trusty and wellbeloved
 friend Thomas Notley Gent to succeed me in the Office and
 Offices of Government of and in the said province untill his Lopp
 Should appoint and authorize some other person to exercise and
 execute the said Offices And his Lopp did by this sume the
 instrument of Instructions allow off authority and appoint the said
 Thomas Notley whom he should so appoint as aforesaid to exercise
 and execute all and every the said Office and Offices Powers & authoritie
 whatsoever after my death untill his Lopp shall nominate & appoint
 some other person or persons to exercise and execute the same And
 his Lopp did therin like manner give me full power and
 Authority for him and in his name in case of the death of any
 Officer or Officers of the said Province or of any of his Lopp
 privy counsell or privy counsellours to appoint other fitting person
 or persons to execute the Office or trust of such person or persons
 So dying as aforesaid untill his Loppes Will should be declared
 to the contrary And his Lopp did thereby authorize such person
 and persons by me to be appointed to execute and exercise such Office
 and Offices according to such my appointment As by the sume writing
 or instrument of Instructions may likewise more at large appear
 Now know ye that if the said George Wharton being at the time
 of his Sealeing and executing of these presents sickle and weaker
 in body but of good sound and perfect mind memory and understanding
 (prayed be almighty God for the same) have in pursuance of the
 - Instructions Orders and Authorities to me given by his said Lopp Charles
 Howard Lord and Proprietary of the provinces of Maryland and
 Avalon Lord Baron of Baltimore as by the last recited writing or
 Instrument of Instructions aforesaid nominated constituted authorized
 and appointed and by these presents do nominate Constitute & appoint
 - his said Thomas Notley Gentleman (in case it shall please God
 - that I shall happen to dye during his Loppes absence out of this
 Province) immediately from and after the decease of me the
 said George Wharton to succeed me the said George Wharton
 in the Office and Offices of Deputy Lieutenant and Deputy Governor
 of the said Province of Maryland under the Honourable
 - Colvert Esq: during his Loppes Absence out of this Province
 or untill his said Lopp shall nominate appoint and authorize
 some other person or persons to exercise and execute the said
 Offices of Government as aforesaid. And I do also by these
 presents authorize and empower (according to my instructions
 aforesaid) the said Thomas Notley to exercise and execute the
 said Office and Offices of Government as Deputy Lieutenant
 Deputy Governor or Justice justice as aforesaid (after my
 decease as aforesaid) and all the several powers & authorities
 aforesaid
