for the better collecting Receiving & getting in our Rents  
Port Duties, Impositions & all other profits perquisites &  
just debts whatsoever in this our Province It is fit and  
requisite some persons should be appointed & Empowered who  
from time to time may Receive Collect Receive & get in the same  
Know ye therefore that we reposing much trust & Confidence in  
our Right Trusty & well beloved Thomas Notley & Benjamin Rozer  
Gents have Empowered Constituted & Appointed and we do  
hereby Empower constitute & Appoint the said Thomas Notley &  
Benjamin Rozer jointly & severally our Receiver & Collectors of  
all our Rents Port Duties Impositions profits perquisites debts  
& due whatsoever in this our Province And to do & performe all  
every thing which to the Office & place of Receiver & Collectors  
belong or any wayes apperteyne And upon Receipt of any Sums  
or Sums of money Goods or Tobacco to us due or belonging Acquitt-  
ances & discharges to make Seals & deliver Hereby Ratifying Con-  
firming & allowing all or whatsoever the said Thomas Notley  
or Benjamin Rozer or either of them shall doe or cause to be done  
by Vertue hereof, with full & ample power under them or either  
of them by Commission under their hands & Seals or under the hand  
& Seal of one of them to constitute & Appoint such Sub Collectors &  
Receivers under them as they shall thinke fit with like or limited  
power And the said Commissions or any of them to Revoke & annul  
at pleasure Willing & hereby Requiring our said Receivers &  
Collectors to call to an account once every year at the Shewffes  
of our severall & respective Counties & at others or Deputy Receivers  
& Collectors who are hereby Required to give in their accounts  
accordingly And upon refusal to Account or delay of payment of  
what shall be due to us from any person whatsoever or howsoever  
the said persons debts & to us to Impleade & prosecute in our name  
Hereby also Demanding all & every our Officers & all the good people  
of our Province to be aiding & assisting to our said Receivers &  
Collectors as becometh Willing also all our Judges Officers & Minis-  
ters of our said Province to allow of this power hereby by us  
Granted to the said Thomas Notley & Benjamin Rozer as a full  
Sufficient & unquestionable authority for them the said Thomas  
Notley & Benjamin Rozer or either of them to Recover all and  
Singular our just dues within our said Province Given under  
our hand & Seal of our said Province of Maryland at our
