The humble Petition of Garrett Vansweeringer

Sheweth That y^e Pet. at y^e laying of the Levy Anno 1677. was allow'd by your
Hono^r and the members of y^e Lower house of Assembly the summe of
thirtie thousand two hundred and two pounds of tobacco to be pay'd by Thomas
Tailor High Sheriff of Dorchester County out of y^e Publick Levy in
the said County w^{ch} said summe the said Thomas Tailor hath recd. and
y^e Pet. did expect to have recd. y^e same for y^e paying of y^e Petitioner
Debts especially for being security for John Lynch Merchant to M^r
Christopher Rowby in y^e summe of 8500. tob. by bond for y^e doubt
quantity, and for ind. y^e Pet. charged a Note upon y^e Thomas
Tailor to pay y^e said 8500. tob. out of y^e said summe of 13000.
tob. w^{ch} the said Thomas Tailor promised to do: and to pay y^e remand.
to y^e Petitioner Ord.
y^e Pet. sheweth to y^e Hono^r. that the said Thomas Tailor hath not
only violat'd y^e Publick faith & neglect'd to pay y^e said summe of tobacco
but hath suffer'd y^e Pet. to be said for y^e non-payment of y^e same
to the great Damag. and Loss of y^e Pet. in his credit and
reputation being in severall respects accordingly thro'ly Damag'd.
And y^e Pet. being for said and Damag'd did at the last Court
file a Bill against the said Thomas Tailor to w^{ch} he refus'd to
appear nor bring arr. and now the Court being adjourn'd for
so long a time y^e Pet. is lik. to lose his Deb. this year also
which will be almost the undoing of y^e Petitioner if not prevent'd
by y^e Hono^r.

y^e Pet. therefore humbly prays y^e Hono^r. consideration in
the premises and to ord. him satisfaction out of the
Bonds given by the said Thomas Tailor to y^e Lord Prop.
for Reparation of his Damag. or to afford him such
other relief as to y^e Hono^r. shall seeme just
and y^e Pet. shall pray &c.
